Sir,

With due respect, I, SI Biswajit Bose of Bhaktinagar PS, Siliguri Police Commissionerate would like to lodge a complaint that while performing K-37 II van duty vide Bhaktinagar PS GDE No. 1701 Dated 29.11.2021 at around 15.00 hrs received information that some chaos was going on at SBFC Pvt. Ltd. office located at City Plaza, Payel More, Sevoke Road, PS Bhaktinagar, Dist. Jalpaiguri. On reaching there, found 15/20 customers present inside the said office and some staffs of SBFC Finance Pvt. Limited were present. On enquiry, it could be learnt that On 29.10.2021 one specific case vide Bhaktinagar PS Case No. 1391/2021 Dated 29.10.2021 u/s 409/420/120 B IPC was registered over the issue of misappropriation of Gold ornaments deposited in SBFC Pvt. Ltd and misappropriation of interest amount paid to the employees. Two employees against whom the FIR was lodged were arrested and were in PC and now in JC. Over this issue company personnel had assured to return the gold to the customers on 29.11.2021 and the customers gathered in the office of SBFC but company represented by Sri. Sourav Bose, Branch Manager of SBFC Finance Pvt. Ltd. could return the gold ornaments as assured to the customers and gave date for handing over gold to customers on 03.12.2021 but the customers protested and customers demanded to Branch Manager to give in writing regarding return of Gold but Branch Manager did not want to give in writing. Then, customers approx 15/20 restrained Branch Manager and other staffs, and assaulted Branch Manager, destroyed / damaged the paper files, furniture and CCTV Camera. The alleged persons also threatened the Branch Manager and other staffs of SBFC Finance Pvt. Limited. with dire consequence if their gold is not returned. I tried to pacify them but they paid no heed and even tried to obstruct police from discharging their lawful duty but somehow situation was brought under control. I asked for the complaint over the incident to Branch Manager and other staffs but they denied submitting stating that let the company higher ups decide. As there was tension and fear of ransack of the office and as per direction of IC PS, I along with force had been there in the office whole night and after ensuring complete safe condition, returned to PS and lodged the complaint.

I, therefore, pray before your kind honour that a specific case may kindly be initiated against the customer.
