Jalpaiguri , West Bengal ,as per Muslim rites, rituals and customs. The said marriage was registered on 14-07-2018, at the office of The Muslim Marriage Registrar and Kazi, Siliguri Sub- Division, Darjeeling, Vide Register-A, Book-I, Vol-I, Serial No -Ext, Pages No. Ex-07/2018.

That my husband, adhaar no.240421590168, Mobile No. 6202050096" native village is c/o Hamidul Khan, Khan Mohalla, Jale Paschim, P.o.& P.S Darbhanga, Dist. Darbhanga- Bihar- PIN-847302.

That after marriage my husband resides with me at my Parents house upto 1 (One) year) and some time took me at his home, and forced me dowry money Rs4,Lacs ffrom my Parents , on denial of un-ability of my Parents my husband has bruiteily assaulted, beated mercilessly and also torture me physically and mentally.

That at the time of marriage my parents have given about 2 Bhorl Gold Ornaments like Ring, Mala etc and Rs. 1,00,000/- hard cash to my husband as dowry. My Parents have also expensed Rs. 4,00,000/- for the both side marriage ceremony expenses.

That out of our wedlock a son named RAYYAN KHAN was born on 15-04-2019 at NBMC&H, the said expenses was also borne on my Parents. My husband has nothing help to my Parents. My Husband was also resides with my Parent in a mess, but he has nothing expenses a single heed of money towards me and my son, all expenses including him also borne on my Parents. At present I and my minor Child look-after and maintained by my Parents.

After born of Child my husband has started quarreling me with slang and dirty languages, also several times attacked on me to finish/ kill by several and different ways. My husband has never look-after me and/ or minor child, always demanded illegal amount of dowry.
