With due respect, I Dipti Biswakarma, w/o Harsha Nagendra, daughter of Jivan Biswakarma resident Gobind Nagar, Champasari, Po/PS Badhan Nagar, Siliguri Dist. Darjeeling would like to inform and report an FIR by being mental tortured, harassed and blackmail by my husband.

We had married under Hindu rites and custom on 14th February, 2021 in Bangalore City which started with fights due to his excessive possessiveness and mental torture. With great difficulties we hardly stayed together almost a month. Day by day his mental torture was increasing where I felt unsafe - In between on 4th May, 2021, I had to come to my hometown (Siliguri) due to father's critical condition in Covid. However, his mental torments, filthy and inappropriate languages towards me still continues. ~~He~~ I don't feel safe to go back with his behaviour towards me.

It is a humble request to you to please take a quick action in this matter as it is impacting me overall towards my health, mental disorder and my work.
