Sir,

In producing herewith one accused person namely Dhiren Roy (39 yrs.), S/o- Lt. Satinal Roy of Samar Nagar Simulbari, Ps- Bhaktinagar, Dist- Jalpaiguri under arrest along with one Toto (E-Rickshaw), red color, bearing registration plate no. WB73F-2481 loaded with iron rods on the roof of the toto and would like to lodged written complaint against him, to the effect that today i.e on 30.11.2021 at about 12.00 hrs. while I SI. Arindam Chatarjee along with ASI. Titu Saha and CV/732 Rakesh Roy was performing traffic regulation duty at Hill Cart road near Junction more, Ps- Pradhan Nagar, Dist- Darjeeling (Which Refer to Junction T.G GDE No.409 Dt-30.11.2021) found the toto (noted above) was coming from Air view side and proceeding towards Darjeeling more, which was carrying protruding iron rod on Toto roof measuring 20 (twenty) ft. in length approx, in such a manner which may be endanger to human life, However intercepted the toto and on asking the driver of the toto could not able to give any satisfactory reason or not able to produce any valid documents in respect of the iron rod which he carrying on his toto in such endanger manner. Hence there is strong reason to believe that it may be stolen articles or it is carrying for any illicit purpose. On demand he produced relevant documents of toto and disclosed his name and address as noted above and also identified himself as the owner of the toto on minutely checking its R.C book, it also could be learnt that the toto is authorized to ply in SMC area except in Hill Cart road although he is plying his toto in Hill Cart road .


Under the circumstances, finding no any alternative, I seized the toto along with all relevant documents and loaded iron rod from his possession ,by preparing proper seizure list in presence of witnesses u/s 102 Cr.P.C and arrest him u/s 41 Cr.P.C.for carrying iron rods in such endanger & suspicious manner

I therefore pray before your kindness that a specific case may kindly be initiated against the accd. Person namely Dhiren Roy (39 yrs.), S/o- Lt. Satinal Roy of Samar Nagar Simulbari, Ps- Bhaktinagar, Dist- Jalpaigur, as per proper section of law


