Ward No. 25, Siliguri, were travelling by their  
Scooty near Children's Park, Ward No. 25 on  
28th November, 2021. They were intercepted by  
anti-social elements in front of Mangal Vastka  
Apartment behind Hindi High School, around 10:40 pm.

The other party started using abusive  
language and called some more people.

Anand then called his elder brother, Sourav to settle the argument. But, instead of settling the matter, the whole group started thrashing Anand, Parikaj & Sourav by hand and legs which left them with multiple injuries in head, mouth, stomach and face.

They broke the Spectacles and mobile phone and then snatched Anand's mobile no. 8509653042 of Samsung S20+ model.

All three were taken to Aregya Niketan Nursing Home and then shifted to Paramount Hospital where CT Scan & other treatments were done on 28<sup>th</sup> night and till 2 am in the morning of 29<sup>th</sup> Nov, 2021.

The final report of CT Scan was received on 29<sup>th</sup> Nov, 2021 evening. The whole family has been in a sense of trauma; so, a FIR could not be filed on 29<sup>th</sup> Nov, 2021; as such I am filing a FIR on 30<sup>th</sup> Nov, 2021.
