I, Sri Subhendu Chowdhury, S/O Late Shardendu Chowdhury, Station Manager, Shivmandir Customer Care Centre do hereby lodge this complain to the effect that Sri Suraj Subba S/O- Sri Indra Prasad Subba Vill. Nayabusty, PO-New Rangia, P.S. Bagdogra, Dist Darjeeling, has committed an offence under section 135(1)(a) of Electricity Act 2003 (Amendment Act 2007) as stated here under.

On 29/11/2021 at about 12:59pm Sri Subhendu Chowdhury, S/O Lt. Shardendu Chowdhury, send JE Gr 2 Ainal Kabir and Technical Support Hand Praveen Chettri at Nayabusty to inspection the Transformer and during inspection they found that Sri Suraj Subba S/O Indra Prasad Subba enjoy electricity by means of Direct hooking to run the water pump having 1/2H.P. The electrical load found in the premises of Sri Suraj Subba during inspection was 350watt. The findings have been incorporated in the inspection report prepared by Sri Subhendu Chowdhury, Station Manager Shivmandir CCC WBSEDCL in presence of Sri Indra Prasad Subba and the witnesses.

As unauthorized use of electricity was detected during inspection, the illegal arrangement was removed in the presence of witnesses and the aforesaid articles were seized at the spot by preparing a seizure list duly signed by his father Sri Indra Prasad Subba.

Since, Sri Suraj Subba S/O- Sri Indra Prasad Subba Vill. Nayabusty, PO-New Rangia, P.S. Bagdogra, Dist Darjeeling, has committed an offence under section 135(1)(a) of the Electricity Act 2003 (Amendment Act 2007), you are hereby requested to take cognizance of this complain and treat this complain as FIR.
