Sir,

In producing herewith one (01) arrested accused person namely Md Hasibul SK (37) s/o Lt. Abdul Aziz of Amarpur PO Dadpur PS Rezinagar Dist. Murshidabad along with following seized articles viz,

- iii. One zipper transparent thin plastic packet in contents 270 grms (two hundred seventy) said to be brown sugar , Market as Exhibit -A.
- iv. 10 (Ten) grams of said to be brown sugar which drawn from exhibit-A as sample for examination packed, sealed, labeled and marked as exhibit-A1.

I, SI Binup Mahato of Bagdogra PS , Siliguri Police Commissionerate do here by lodged this complaint against one accused person namely Md Hasibul SK (37) s/o Lt. Abdul Aziz of Amarpur PO Dadpur PS Rezinagar Dist. Murshidabad to the effect that on 01.12.21 at 14-35 hrs received a secret source information that one person having possession huge quantity of brown sugar is standing at Bihar More near Bus Stoppage for clandestinely disposal the same illegally and he could be caught red handed if apprehended immediately. The matter was diarized vide Bagdogra Ps GDE No- 30 dt- 01.12.21. Accordingly, I informed the matter to O.C, Bagdogra PS. As per his instruction myself along with ASI Dharendra Nath Mandal, C/410 Montosh Singh, CV/389 Janak Singha, CV-386 Kishor Ranjan Howlader and Mobile van K-36 officer ASI Subhash Ch Roy and force left for the spot at 14-45 hrs to verify the veracity of the information by Govt. vehicle bearing No. WB-77-A-2580 vide corresponding Bagdogra PS GDE No. 31 dt. 01.12.21 and M.C.C No- 4168/21 Dt.01.12.21.

At the time of departure from Police Station, I bring spring weighing clock, small balance with stone, envelope, paper, sealing wax, gum, seal etc. On way to spot at Bihar more, I called two independent witnesses namely i) Sunny Sharma (32) s/o Lt. Chandrilal Sharma of Hospital More , Bagdogra PS Bagdogra Dist, Darjeeling ii) Md Nausad (23) s/o Md Manjur of Batlabari , Gossainpur PS Bagdogra Dist. Darjeeling informed them about the information in hand and requested them to accompany us to witness the search and seizure if necessary. At about 15-05 hrs on arrival there by Govt. vehicle as identified by the source we surrounded the place and found that one young male person was standing at Bihar More near Bus Stoppage, on seeing police party , he tried to flee. On hot chase, we apprehended the said person. On being asked he disclosed his identity as noted above. After disclosing our identity, I asked him whether he wanted to be searched in presence of Executive Magistrate or any Gazetted Officer and he agreed to search by any one. I served him option notice u/s 50 of NDPS Act accordance with provisions of law in this regard in writing and he also gave his approval of being searched by any one in writing in the notice. Accordingly, I informed the matter to O.C. Bagdogra PS and he informed me over mobile phone to send letter to Sri Pasang Topgay Bhutia ,ACP, Traffic (West), SPC. Accordingly, I informed to Sri Pasang Topgay Bhutia ,ACP, Traffic (West), SPC in written by sending messenger with letter and request him to come immediately to the spot. At about 16.30 hrs Sri Pasang Topgay Bhutia ,ACP, Traffic (West), SPC and O.C. Bagdogra PS arrived at the spot. I disclosed the identity of Sri Pasang Topgay Bhutia ,ACP, Traffic (West), SPC to the accused person as Special Executive Magistrate on the day and also witnesses. I also offered the independent witnesses and the accused person to search our Police Party as per provision of law. But they refused to search the police party. Under supervision of Sri Pasang Topgay Bhutia ,ACP, Traffic (West), SPC and in presence of independent witnesses, I conducted searched and recovered One zipper transparent thin plastic packet in contents said to be brown sugar from his right pocket of pant . On demand in presence of the Gazetted Officer Sri Pasang Topgay Bhutia ,ACP, Traffic (West), SPC he failed to produce any valid document in support of possessing of the same.

Accordingly weighed the recovered said to brown sugar by the weighing instrument and found total 70 grms said to be brown sugar in one zipper transparent thin plastic packet Marked as Exhibit -A and 10 Grams said to brown sugar taken as sample from the Exhibit -A in one separate thin plastic packet marked as A1. I labeled and sealed all the article in presence of Sri Pasang Topgay Bhutia ,ACP, Traffic (West), SPC and independent witnesses and accused person. Then I seized the above noted articles under proper seizure list duly signed by the above noted witnesses and the Gazeted officer Sri Pasang Topgay Bhutia ,ACP, Traffic (West), SPC and acknowledged by the accused person. On further asked the apprehend person confessed in presence of Gazetted Officer Sri Pasang Topgay Bhutia ,ACP, Traffic (West), SPC and other witnesses that he procured the said brown sugar clandestinely for the purpose of selling at Bagdogra area in order to earn huge money illegally . Then I arrested the above noted accused person u/s- 41 Cr.P.C after observing all formalities of arrest as well as after disclosing the cause of arrest and issued Memo of Arrest .The copy of seizure list and Memo of Arrest has been supplied to above noted accused person as the accused person violated the terms and condition of NDPS Act . The seizure was made between 16-55 hrs to 18-15 hrs.

Under the above circumstances, I pray to you that a specific case under proper section of Law may kindly be started against the accused person namely Md Hasibul SK (37) s/o Lt. Abdul Aziz of Amarpur PO Dadpur PS Rezinagar Dist. Murshidabad and arrange for its investigation.
