I, Ashok Kumar Goyal S/o Late Prayag Chand Goyal being the constitute attorney holder of Sri Ratanlal Agarwal, Son of Sri Kishanlal Agarwal for and behalf of me as well as (1) Rajendra Kr. Agarwal S/o Late Jayanti Prasad Agarwal (2) Kishanlal Agarwal S/o Late Kamla Prasad Agarwal (3) Mahendra Kumar Agarwal S/o Late Jayanti Prasad Agarwal (4) Pradip Kr Agarwal S/o Late Laxmichand Agarwal, all are residents of Sevoke Road, P.O: Sevoke Road, Siliguri (5) Sri Amit Kedia, S/o Sri Suresh Kr. Kedia do hereby lodge this written complaint before your office with my sincere expectation that an effective action be taken by your good office.

That I along with others as mentioned above became the owner of all that piece and parcel of land measuring equivalent to 0.3146 Acres situated at J.L.No. 2, Sheet No. 9, comprised in R.S.Khation No. 136/1 and 143 appertaining to R.S.Plot No. 148 & 150/440 by virtue of different sale deeds executed by the then owner of land and therefore we the above named applied for record our names in the Record of Right before the B.L & LRO office as per W.B.L.R Act, which was duly verified & considered and our names were respectively recorded in the R.O.R and accordingly L.R.Khation No. 160, 166, 167, 168, 174 and 159 were opened in Dabgram L.R Sheet No. 53, L.R. Plot No. 8 in Rajganj Block (Jalpaiguri District), which exists till date.

That some Local goons and local speculators, Uttam Roy, Son of Prasanta Roy, Wazed Ali Sekh, S/o Hala Luddin Sheikh, both residents of Haiderpara, P.s: Bhaktinagar with others have forcefully trespassed upon our land several times, with the help of locals & good neighbours everytime were removed from our said land. Complaints (Several) were filed against them. Two Criminal cases were filed by P.S. in the Courts against them bearing cases no. 259/19 & 474/19.

Uttam Roy filed a T/sheet No. 429/2018 on 24-12-2018 with support of Duplicated/manipulated papers which was Dismissed on 20-11-2019 by the Honorable Court (Civil Judge, Junior Division, Jalpaiguri court).

That Bikash Goyal, Pradip Kumar Agarwal, Rajkumar Sharma & few other's along with Renowned Land mafia's- Uttam Roy and Waxed Ali Sheikh in convince and with criminal conspiracy with other hooligans of the locality are time and again disturbing our peaceful possession of land and with their muscle power threat our caretaker's. They several times broken our main gate padlocks and removed our names written on it. Complaints were made/ lodged in Bhaktinagar P.S. They (Landmafia's) are forcefully trying to grab our land.

It is therefore prayed before your good office to look into the matter on urgent basis and take strict action against these persons with criminal intent

Hence it is prayed before your good office to look into the matter and punish the culprits.
