Sir,

In producing herewith one arrested accused person namely Biplab Sarkar (39) s/o Late Purna Sarkar of Bikash Nagar near Radha Krishna Mandir, P.O Salugara, PS Bhaktinagar, Dist Jalpaiguri along with the seized articles viz,

- 1] Four (04) Bottles of KINGFISHER STRONG PREMIUM BEER each BOTTLE containing 650 ml
- 2] Nine (09) Bottles of Himalayan Gold 60UP Country Spirit each Bottle containing 600 ML
- 3] Seven (07) Bottles of Himalayan Gold 60UP Country Spirit each Bottle containing 300 ML

I, PSI Sailesh Subba of Bhaktinagar PS, SPC would like to lodge this written complainant against the above noted arrested accused person to the effect that on 03.12.2021 at around 17.15 Hrs while performing mobile van duty received a source information that one person has gathered huge amount of liquor illegally in his Hotel at Bikash Nagar, Salugara, PS Bhaktinagar, Dist Jalpaiguri for selling the same to local customer for his wrongful gain. Accordingly I, informed you about the information and as per your kind instruction, I along with C/762 Mujibur Rahman, CVF/604 Sumit Kr Roy and CVF/619 Bhamendra Roy of Bhaktinagar PS/SPC headed towards Salugara to work out the information. At 17.45 hrs we reached at the spot, and after being shown by the source I, along with force entered the aforesaid Hotel and apprehend one person who disclosed his identity as noted above and searched the Hotel and recovered above noted seized articles. On demand of Licence or Documents for storing and selling the liquor, he could not produce the same. During enquiry he admitted his guilt before us and stated that he has been selling the same to local customer since long for his wrongful gain. I then prepared seizure list of the above noted articles in presence of witnesses undersigned of seizure list. The seizure was made between 18:05 hrs to 18:25 Hrs. I arrested the said accused person u/s 41 Cr.P.C after observing all the formalities and issued Memo of arrest appraising the ground of arrest in presence of witnesses.

I therefore request you to kindly register a specific case against the accused person namely Biplab Sarkar (39) s/o Late Purna Sarkar of Bikash Nagar near Radha Krishna Mandir, P.O Salugara, PS Bhaktinagar, Dist Jalpaiguri under proper section of law.
