Sir,

In producing herewith 01 accused person namely Raghunath Biswas (37 yrs) s/o Lt. Shanti Biswas of Rangapani Bazar PS Bagdogra Dist. Darjeeling along with seized articles viz (1) 15 ( fifteen ) bottles of Himalayan Gold" premium 60 up Country spirit of 600 ml each and (2) One Nylon Bag which used to carry SL No. 1 of the seized articles .

I SI Binup Mahato, Bagdogra PS, SPC do hereby lodge a written complaint against the above noted accused person to the effect that on 03.12.21 at 22-35 hrs. received a secret source of information to the effect that one person is stoking and selling huge quantity of country spirit from his shop styled as Hotel Smarat at Ranidanga, under PS- Bagdogra . Accordingly the information was diarised vide Bagdogra PS G.D.E. No. 145 dtd. 03.12.21 . Thereafter I apprised the matter to the O.C. Bagdogra PS and as per his direction I along with ASI Dharendra Nath Mandal , C/410 Monotosh Singh , VP-01 Anselam Kujur , VP-02 Pradip Roy and mobile van-36 officer ASI Kanchan Das with force , all of Bagdogra PS left from Police Station to work out the secret source information vide Bagdogra PS GDE NO. 146 dtd. 03.12.21, on arrival at Ranidanga at 23-15 hrs being pointed out by the source , found that the above noted accused person is selling country spirit/ Id. Liquor from his shop i.e. Hotel Samrat . Accordingly I with the help of my officer and force held raid in that shop and apprehended one person of that shop who admitted himself owner of that shop, but customers managed to flee away from there and during search I recovered 15 ( fifteen ) bottles of Himalayan Gold" premium 60 up Country spirit of 600 ml each which kept in One Nylon Bag in presence of two disinterest witnesses. During interrogation he disclosed his name and address mentioned above and on demand he failed to produce any documents/ License in support of the said recovered country spirit/Id. Liquor and he stated that he sale the same to the local public at that area with a view to earn huge money for his livelihood. Accordingly I seized the recovered country spirit/ Id. Liquor from the possession of the above noted accused person as per proper seizure list and labeled the same in presence of witnesses duly sign by them and accused person also. The seizure & arrest was made between 23-25 hrs to 00-25 hrs ( Total 9 Ltrs ) and explaining charge against him.

Hence, Under the above noted circumstances I am submitting this written complaint against the accused person namely Raghunath Biswas (37 yrs) s/o Lt. Shanti Biswas of Rangapani Bazar PS Bagdogra Dist. Darjeeling for starting a case under proper section of law and to arrange for its investigation.
