Sir,

In producing herewith arrested accused person namely Ganesh Sahani (22 yrs) S/O Late Bishnudev Sahani of Rana Busty, Ward No. 18, PS- Siliguri, Dist- Darjeeling along with seized articles vize- i) 28(Twenty eight ) sealed Bottles of Himalayan Gold 60 up country spirit each containing 300 ml. each labeled as Himalayan Endeavour PVT. Ltd. Siliguri, West Bengal @ Rs 60 each (Amounting of Rs 60/- x 28 =RS.1680/-) in which one sealed bottle has taken from mother packet box as sample and ii) 03 sealed bottles of Kingfisher Strong premium Beer containing 650 ml each/-in which one sealed bottle has taken from mother packet box as sample as per seizure list.

I, ASI Siben Sarkar of Siliguri PS, SPC do here by lodged a written complaint against above noted arrested accused person Ganesh Sahani (22 yrs) S/O Late Bishnudev Sahani of Rana Busty, Ward No. 18, PS- Siliguri, Dist- Darjeeling to the effect that on 03.12.21 at 21.35 hrs acting on secret information, I received a source information that the above noted person was busy to sale Id liquor illegally in his father in law's house situated at Tikiapara Matangini-II, Ward No. 28, under Siliguri PS in order to clandestinely dispose the same. Accordingly the fact is diarized in GD vide Siliguri PS GDE no. 161 dated 03.12.21 and informed the fact to I/C Siliguri PS. As per direction of I/C Siliguri PS, I along with ASI Subir Sen, ASI Dhruba Misra, CV-283 Prosenjit Dey, CV-622 Ramanath Barman left for Tikiapara Matangini-II, Ward No. 28, under Siliguri PS to verify the veracity of the information. On reaching at 21.55 hrs there and as identified by source cordoned the above noted area where he was selling illegal alcohol. On seeing the police party the above noted person tried to escape from the spot but we managed to apprehend the above noted person and on interrogation, he disclosed his identity as noted above. On being asked he stated that he used to sale the 60 up Country Spirit to locality without any valid documents as he has violated the norms of Bengal Excise Act for selling the said seized articles without any valid license. 28(Twenty eight ) sealed Bottles of Himalayan Gold 60 up country spirit each containing 300 ml. each labeled as Himalayan Endeavour PVT. Ltd. Siliguri, West Bengal @ Rs 60 each (Amounting of Rs 60/- x 28 =RS.1680/-) in which one sealed bottle has taken from mother packet box as sample and ii) 03 sealed bottles of Kingfisher Strong premium Beer containing 650 ml each/-in which one sealed bottle has taken from mother packet box as sample which was kept concealed in his father in law's house situated at Tikiapara Matangini-II, Ward No. 28, under Siliguri PS. On being interrogation he could not produce any valid documents in respect of the said liquor. He also stated that he is doing this liquor business since long for wrongful gain. Accordingly I seized the same in presence of witness duly signed by them. The seizure and label was made in between 22.15 hrs to 23.05 hrs. As such I arrested her U/S-41 Cr.P.C after observing all sorts' of rules.

Therefore I pray before your honor that a specific case may kindly be started against the arrested accused person namely Ganesh Sahani (22 yrs) S/O Late Bishnudev Sahani of Rana Busty, Ward No. 18, PS- Siliguri, Dist- Darjeeling along with seized articles under proper section of law and arrange for its investigate.
