In producing herewith five (05) arrested accused persons who disclosed their name & identity as (i) Ujjal Biswas (26) S/O Sri Kshitish Biswas, Isekon Mandir Road, Ektiarsal Bazar, PS-Bhaktinagar, Dist-Jalpaiguri, (ii) Parimal Barman (27) Lt. Manglu Barman of Sahudangi, PS-NJP, Dist-Jalpaiguri, (iii) Biswajit Khatriya (24) S/O Sri Dulal Khatriya of Pachim Dhantala, PS-NJP, Dist-Jalpaiguri (iv) Subanta Barman (28) S/O Sri Subhas Barman of Sahudangi, PS-NJP, Dist-Jalpaiguri (v) Bikram Barman(27) S/O Haripada Barman of Sahudangi, PS-NJP, Dist-Jalpaiguri. I, SI Uttam Kumar Baghira of Siliguri PS/ SPC do hereby lodge complaint against the above noted arrested persons to the effect that, on 03.12.2021 at 23.25 hrs during my R/T Mobile Van duty had been to Air View More area, Siliguri and found the above noted persons were gathered/ roaming without wearing mask on their face and without any proper reasons.

On being asked, the above noted persons stated before me that, they were well aware of the pandemic situation and they supposed to remain in home and not to come out without any valid reason and valid movement pass issued by the local Police authority or civil administration.

Hence, they violated the order of Govt. of West Bengal duly promulgated in order No. 753/XV- ISS/2M-22/2020 Dated.30.11.2021. The above noted persons have intentionally refused to comply with the order of Govt. of West Bengal duly promulgated in view of break-out of pandemic COVID-19 throughout the country. Accourding, I arrested above noted persons u/s- 41 Cr.P.C in c/w the case after observing all rules and formalities.

Now, I request you for starting a case u/s- 188/269/270 IPC R/W Sec. 51(b) Disaster Management Act, 2005 against the above noted arrested accused persons and arranged proper investigation of the case.
