Respected Sir,

With due respect I, the undersigned would like to inform you that I am the legally married wife of Sri Ravi Roy, son of Sri Dinesh Roy, resident of c/o Hari Debnath, Fokdoi Bari, Ranjit More. P.S. Bhaktinagar, Dist. Jalpaiguri at present residing at Housing Board Colony, Dist. Hanumangarh, Rajasthan - 335512 and the said marriage was solemnized according to hindu rites and customs on 10-08-2009 in the house of the maternal Uncle of my husband at Fokdoi bari, Ranjit More, P.S. Bhaktinagar, Dist. Jalpaiguri.

I would like to further inform you that at the time of the said marriage, as per the demand of my husband, my father in-law Sri Dinesh Roy, my mother-in-law Smt. Pushpa Roy and the maternal uncle of my husband Sri Hari Debnath, my parents fulfilled the said demand and they have given a sum of Rs. 50,000/- (Rupees Fifty Thousand) only to my husband in cash, valuable gold ornaments, furniture, utensils, etc. at the time of the said marriage.

I would like to further inform you that after the said marriage, and after elapsing of few days from the date of the said marriage, I was brought by my husband in his working place at Rajasthan along with the said stridhan properties and we started to live together as husband and wife in the joint mess with my other in-laws there and out of the said wedlock I gave Birth to a male child on 27-02-2011.

I would like to further inform you that till the date of the birth of my son I was quite happy with my husband and in-laws but after the birth of the said new born baby, my husband and my other in-laws have started to misbehave with me just without any reasonable cause and gradually the said torture both mentally and physically have been accelerated by my husband and in-laws upon me and on some occasion, they did not allow me to have food including

the said infant and we were compelled to sleep in empty stomach and they also refused to provide the medicine and feeding to the said infant and ultimately I was brought by my husband in my paternal house on 21-09-2016 and started to live in my paternal place with my said minor son.

I would like to further inform you that my husband left me and my minor son in my paternal house and before leaving he started to put pressure upon me to ask my parents to pay him a sum of Rs. 2,00,000/- (Rupees two lakhs) only for starting his new business and on refusal and unable to pay the said amount, my husband has assaulted me brutally on 24-09-2016 at night after having plenty of liquor. On the next day i.e. on 25-09-2016, I informed the said misbehavior of my husband to the maternal uncle of my husband Sri Hari Debnath who was the mediator of my marriage and after getting the said information, very surprisingly he supported the demand of my husband and directed my parents to fulfill the said demand of money.

I would like to further inform you that on 26-09-2016, my husband told me that if my parents will not fulfill the said demand of money as early as possible, he has no option but to leave me and my minor son and enter into another marriage with a handsome dowry and he left the place of my parents on 26-09-2016.

I would like to further inform you that after elapsing of few months from the date of the said leaving as stated above, my parents considering my future and for my minor son they had arranged a sum of Rs. 1,20,000/- (Rupees One Lakh Twenty Thousand) only by taking personal loan from the family members and the same was informed to my husband and after getting the said information, my husband and my mother-in-law came to our place in the middle of the February, 2017 and my parents tried to convince them to receive the said amount and at the same time my parents have also requested them to accommodate some time for arranging the remaining amount and they received the said amount and again left me and my minor son and thereafter my husband used to call me over the phone to know that whether my parents have arranged the said remaining amount or not.

I would like to further inform you that in the first week of the month of January, 2020 my husband again came to my place and after knowing that my parents could not arrange the said remaining amount, he again started to torture upon me in the same fashion and after elapsing of few days he again left me and my minor son.

I would like to further inform you that after the Covid-19 pandemic situation, on several occasions, I requested my husband to bring back me and my minor son for his future education but my husband did not pay any heed to that and he is only concerned with the demand of his money and yesterday i.e. on 22-10-2021 my husband informed me to forget him and also forget about the matrimonial relation with him as because my parents could not fulfill his demand and he is going to the second marriage with his full demand and at the same time he threatened me by saying that if I will enter into the jurisdiction of my husband, he will not hesitate to kill me and my minor son and till this day I did not take any legal action against the illegal act of my husband and in-laws considering the future of my minor son but at this time I have no other option but to lodge the present complaint.

Under the above circumstances, I would like to request you to investigate the matter and do needful for the ends of justice.
