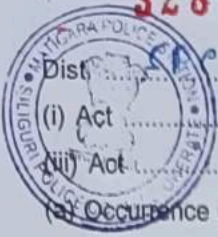

**Subject: FIR**

Sir,

In producing herewith one vehicle (Shaktiman) having Registration no- WB- 59 C-6575 loaded with river bed materials under proper seizure.

I, PSI Newton Biswas of Matigara Police Station, Siliguri Police Commissionerate do hereby lodge this complaint against the driver cum owner of vehicle (Shaktiman) having Registration no- WB- 59 C-6575 loaded with river bed materials to the effect that on 03.12.21 at 22.45 hrs while performing special checking duty vide MTG PS GDE No-139 dated -03.12.2021, I along with force had been to Matigara Dry Fish Market and found that one vehicle (Shaktiman) having Registration no- WB- 59 C-6575 loaded with river bed materials coming from Balason Ghat towards Matigara side. I tried to stop the above noted vehicle being loaded with river bed materials at Matigara Dry Fish Market. On being given signal to stop the above vehicle driver fled away leaving the vehicle. Accordingly I tried to apprehend the driver but in vain. I searched the every possible places and also wait for the claimant of the said vehicle. Nobody turned up as claimant of the said vehicle. There is reason to believe that the said vehicle (Shaktiman) has been involved in carrying of river bed materials by illegal means for their wrongful gain. Finding no other alternative as such I seized the above noted vehicle loaded with river bed materials under proper seizure list. The whole process of seizure was made in between 00.03 hrs to 00.10 hrs.

Hence, I pray that a specific case may kindly be started against the driver cum owner of above noted vehicle (Shaktiman) having Registration no- WB- 59 C-6575 loaded with river bed materials under proper section of Law and arrange for its investigation.
