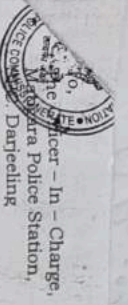

Sir,

In producing herewith the arrested accused persons namely (1) Abhishek Roy (M/18yrs) S/O- Dabari Roy of Radhika Basyi, P.O- Sushrutnagar, P.S- Matigara, Dist- Darjeeling (2) Chandrakanta Barman(M/24) S/O- Suresh Barman of Boropathu, P.O- Ramdanga, P.S- Bagdogra, Dist- Darjeeling (3) Gopal Barman (M/21yrs) S/O- Suresh Barman of Bharatsinghote, P.O- Ramdanga, P.S- Bagdogra, Dist- Darjeeling (4) Akash Roy(M/22yrs) S/O- Bkash Roy of Bharatsinghote, P.O- Ramdanga, P.S- Bagdogra, Dist- Darjeeling (5) Subham Prasad(M/25yrs) S/O- Monahar Prasad of Panjlabpara, P.O+P.S- Siliguri, Dist- Darjeeling (6) Ranjit Roy(M/25yrs) S/O- Ranbri Roy of Kawakhali, P.O-Sushrutnagar, P.S- Matigara, Dist- Darjeeling arrested u/s 41 Cr.PC do hereby lodge a written complaint against him.

In this regard, I beg to state that on 04/12/2021 at about 16.35 hrs. While performing special mobile duty vide GDE No: 101 DT: 04/12/2021, received information that some people are violating the order of Lockdown and roaming aimlessly at Chhatat Medical More. Informed O/C, Matigara PS and as per his direction, I along with force had been to Chhatat Medical More under NBMC & Hospital OP and arrested the above noted accused person. Thereby completely violating the lockdown measures issued by Chief Secretary West Bengal vide order no. 618-ISS/2M-22/2020 DTD.30/04/2021 and 622-ISS/2M-22/2020 DTD. 1st May 2021 issued by the Ministry of Health & family Welfare, Government of India Order no. 403/2020-DM-1(A) Dtd.29/04/2021 and Order No.647-ISS/2M-22/2020 DTD.15/05/2021. On seeing police, he tried to flee away but somehow, the above noted person could be apprehended. On interrogation, he disclosed his name and address as noted above. On further interrogation, he admitted that he was aware of the lockdown Order and Restrictions imposed upon the movement of human being and shops. As he has violated the Lockdown Order promulgated by the appropriate Government Authority and also the provision of Disaster Management Act, 2005, I with the help of force arrested him U/S 41 CrPC by issuing him memo of arrest.

I, therefore pray that a specific case under proper section of law may kindly be initiated against the above noted arrested accused person.
