With due respect, I am producing herewith the arrested accused persons namely (i) Krishna Dey (24 yrs) S/O late Sukumar Dey of D.S. Colony, PS- NJP, Dist.- Jalpaiguri (ii) Ajoy Basfore (24 yrs) S/O late Sepai Basfore of Raja Holi, PS- NJP, Dist.- Jalpaiguri (iii) Biswanath Roy @ Kancha (27 yrs) S/O Joydeb Roy of Baribhasa, Behind Politechnic College, PS- NJP, Dist.- Jalpaiguri (iv) Ranjan Sahani (21 yrs) S/O Santalal Sahani of South Shanti Nagar, PS- NJP, Dist.- Jalpaiguri (v) Kartik Roy (23 yrs) S/O Nemai Roy of South shanti Nagar, PS- NJP, Dist.- Jalpaiguri and (vi) Bappa Roy (26 yrs) S/O Pradip Roy of Near Noukaghat, Moni Bekery, PS- NJP, Dist.- Jalpaiguri and the following articles under seizure :-

1. One iron made sharp cutting weapons called as Bhojali from the possession of accused Krishna Dey S/O late Sukumar Dey of D.S. Colony, PS- NJP, Dist.- Jalpaiguri.
2. One sharp cutting knife and one torch light and from the possession of accused Ajoy Basfore S/O late Sepai Basfore of Raja Holi, PS- NJP, Dist.- Jalpaiguri.
3. One sharp cutting knife and one sharp cutting weapon called as hasua from the possession of accused Biswanath Roy @ Kancha S/O Joydeb Roy of Baribhasa, Behind Politechnic college, PS- NJP, Dist.- Jalpaiguri.
4. One iron made rod and one knife from the possession of accused Ranjan Sahani S/O Santalal Sahani of South Shanti Nagar, PS- NJP, Dist.- Jalpaiguri.
5. One Bhojali form the possession of accused Kartik Roy S/O Nemai Roy of South shanty Nagar, PS- NJP, Dist.- Jalpaiguri.
6. One sharp cutting knife and one torch light from the possession of accused Bappa Roy S/O Pradip Roy of Near Noukaghat, Moni Bekery, PS- NJP, Dist.- Jalpaiguri .

I, SI Samik Paul of NJP PS, Siliguri Police Commissionerate beg to state that on 30.11.21 at 22.45 hrs myself along with ASI Khagen Barman, ASI Sajal Das, , C/1053 Paresh Rava, VP/13 Jamirul Islam, VP/08 Laxman Roy, CV/306 Bisawajit Roy, and CV/824 Niru Yadav left the PS to perform night petrolling duty vide NJP PS GDE No 1311 dated 30.11.21. During my duty on 01.12.21 at about 00.45 hrs I received a secret source information that a gang of miscreants come at near IOC over bridge under PS- NJP, Dist.- Jalpaiguri with deadly weapons and assembled there and making preparation for committing dacoity at Baribhasa area. Accordingly, I informed the fact to you as well as Asstt Commissioner of Police, East -II, SPC about the information in hand. I also informed the fact to night RT Van officer SI Kamalesh Joarder and ASI Amal Debnath and requested them to come to near IOC Over bridge to accompany with us. On 01.12. 21 at 01.35 hrs we arrived at near IOC over bridge under PS- NJP, Dist.- Jalpaiguri. After a few time RT Van officer SI Kamalesh Joarder and ASI Amal Debnath along with force came to near IOC over bridge and accompany with us. At about 01.55 hrs as indicated by the source we noticed that 10/12 persons assembled in a dark place at near IOC Over Bridge, PS- NJP, Dist.- Jalpaiguri and they were whispering in a very low voice. Accordingly, we cordoned the place properly and approach towards them very slowly and carefully but seeing the police party they started to flee away but we the police party managed to apprehended 06 (Six) of them. On interrogation the apprehended accused persons disclosed their name and identity as noted.
