Sir,

With due respect, I am producing herewith one arrested accused person namely Goutam @ Gobinda Biswas S/O late Haripada Biswas of Purba Dhantala, Battalion More, PS-NJP, Dist.- Jalpaiguri under arrest and the following articles under seizure. The ground of arrest duly been communicated with him.

1. 25 (Twenty five) bottles of 60 Up Himalayan Gold Country Spirit containing 600 ml in each bottle.

I, SI Samik Paul presently attached with NJP PS under your kind control beg to state that today i.e. on 03.12.21 at 17.55 hrs I received a secret source information that one person namely Goutam @ Gobinda Biswas of Purba Dhantala, Battalion More under PS-NJP, Dist.- Jalpaiguri is selling ID liquor illegally at Battalion More under PS- NJP, Dist.- Jalpaiguri for his illegal gain. Accordingly, I diarized the fact in the General diary vide NJP PS GDE No 123 dated 03.12.21 and informed the fact to you. As per your kind direction and instruction myself along with ASI Khagen Barman, ASI Sajal Das, HG/794 Ranjit Roy, CV/306 Bisawajit Roy and CV/824 Niru Kr Yadab all of NJP PS, SPC left for Battalion More to work out the information in hand. At about 18.25 hrs we arrived at Battalion More and being shown and identified by the source I held raid and managed to apprehend one person. During interrogation he disclosed his identity as noted above. During further interrogation he disclosed that he is selling ID liquor at Battalion More since long for his illegal gain. As per his leading statement and being shown by him I recovered the above noted I/D liquor which he kept hidden beside a drain. On demand he failed to produce any documents/licence in respect of store/sale the I/D liquor in his possession. Accordingly, I seized the above noted I/D liquor from his possession under proper seizure list and arrested him under proper memo of arrest and observing all the formalities of arrest. The whole process of search, seizure & arrest was made in between hrs 18.45 hrs to 19.25 hrs on 03.12.21.

Under the above noted fact and circumstances, I, therefore, pray before your kind honour that a specific case under proper section of law may kindly be started against the arrested accused namely Goutam @ Gobinda Biswas S/O late Haripada Biswas of Purba Dhantala, Battalion More, PS- NJP, Dist.- Jalpaiguri and arrange for its investigation.
