Sir,

With due respect, I am producing herewith one arrested accused person namely Arjun Das @ Jhunu S/O Mantu Das of Fulbari Super Market, PS- NJP, Dist.- Jalpaiguri under arrest and the following articles under seizure. The ground of arrest duly been communicated with him.

1. 27 (Twenty seven) bottles of 60 Up Himalayan Gold Country Spirit containing 300 ml in each bottle.

I, SI Goutam Mallik presently attached with NJP PS under your kind control beg to state that today i.e. on 04.12.21 at 00.05 hrs I received a secret source information that one person namely Arjun Das @ Jhunu of Fulbari Super Market under PS-NJP, Dist.- Jalpaiguri is selling ID liquor illegally at Fulbari Super market under PS- NJP, Dist.- Jalpaiguri for his illegal gain. Accordingly, I diarized the fact in the General diary vide NJP PS GDE No 142 dated 04.12.21 and informed the fact to you. As per your kind direction and instruction myself along with ASI Sajal Das, and CV/824 Niru Kr Yadab all of NJP PS, SPC left for Fulbari Super Market to work out the information in hand. At about 00.25 hrs we arrived at Fulbari Super Market and being shown and identified by the source I held raid and managed to apprehend one person. During interrogation he disclosed his identity as noted above. During further interrogation he disclosed that he is selling ID liquor at Fulbari Super Market since long for his illegal gain. As per his leading statement and being shown by him I recovered the above noted I/D liquor which he was kept hidden in a shop. On demand he failed to produce any documents/licence in respect of store/sale the I/D liquor found in his possession. Accordingly, I seized the above noted I/D liquor from his possession under proper seizure list and arrested him under proper memo of arrest and observing all the formalities of arrest. The whole process of search, seizure & arrest was made in between hrs 00.55 hrs to 01.40 hrs on 04.12.21.

Under the above noted fact and circumstances, I, therefore, pray before your kind honour that a specific case under proper section of law may kindly be started against the arrested accused namely Arjun Das @ Jhunu S/O Mantu Das of Fulbari Super Market, PS- NJP, Dist.- Jalpaiguri and arrange for its investigation.
