Sir,

With due respect, I am producing herewith one arrested accused person namely Dibakar Roy (35 yrs) s/o Hari Prasad Roy of Kanchanbari, PS- NJP, Dist.- Jalpaiguri under arrest and the following articles under seizure. The ground of arrest duly been communicated with him.

1. 30 (Thirty) bottles of 60 Up Himalayan Gold Country Spirit containing 600 MI in each bottle.

I, SI Samik Paul presently attached with NJP PS under your kind control beg to state that today i.e. on 04.12.21 at 00.45 hrs I received a secret source information that one person namely Dibakar Roy of Kanchanbari under PS- NJP, Dist.- Jalpaiguri is selling ID liquor illegally at his residence at Kanchanbari under PS- NJP, Dist.- Jalpaiguri for his illegal gain. Accordingly, I diarized the fact in the General diary vide NJP PS GDE No 143 dated 04.12.21 and informed the fact to you. As per your kind direction and instruction myself along with ASI Khagen Barman, HG/794 Ranjit Roy and CV/306 Bisawajit Roy all of NJP PS, SPC left for Kanchanbari to work out the information in hand. At about 00.45 hrs we arrived at Kanchanbari and being shown and identified by the source I held raid and managed to apprehended one person. During interrogation he disclosed his identity as noted above. During further interrogation he disclosed that he is selling ID liquor at Kanchanbari area since long for his illegal gain. As per his leading statement and being shown by him I recovered the above noted I/D liquor which he was kept hidden in a room. On demand he failed to produce any documents/licence in respect of store/sale the I/D liquor found in his possession. Accordingly, I seized the above noted I/D liquor from his possession under proper seizure list and arrested him under proper memo of arrest and observing all the formalities of arrest. The whole process of search, seizure & arrest was made in between hrs 01.05 hrs to 01.50 hrs on 04.12.21.


Under the above noted fact and circumstances, I, therefore, pray before your kind honour that a specific case under proper section of law may kindly be started against the arrested accused namely Dibakar Roy (35 yrs) s/o Hari Prasad Roy of Kanchanbari, PS- NJP, Dist.- Jalpaiguri and arrange for its investigation.
