In producing herewith 02 (two) arrested persons namely (i) **Bukanla Das 48yrs** s/o Lt Subodh Das of Chata Gali, Chinsurah, PO+PS -Chinsurah, Dist Hoogly at present C/o Abhishek Pradhan of Shyam Mandir Goli, Upper Bhanunagar, ward No-43, PS Bhaktinagar Dist Jalpaiguri and (2) **Bishal Lama-21yrs** s/o Lt Amar Singh Lama of Madhya Madarihath Dist Alipurduar A/p- C/o Bijay Rai of Bedgara near Primary School, PS Bhaktinagar Dist Jalpaiguri along with all connecting paper.

I, SI Srimanta Chatterjee of Bhaktinagar Police station under Siliguri PS, SPC do hereby lodge complaint against the above noted arrested persons, to the effect that on 04.12.21 at about 23.20 hrs while on performing Special mobile van duty against COVID-19 rules & guidelines. Myself along with ASI Dipak Karmakar, ASI Bhushan Singh, Const/374 Debraj Biswas, Const/762 Mujibul Rahaman, CVF/614 Sumit Kumar Roy, CVF/935 Bipallab Roy all of Bhaktinagar PS under Siliguri PS had been to Worth the Hype restaurant-Cum-Bar at Planet Mall (Bhaktinagar PS GDE No- 216 dated 04.12.21) and found that huge unnecessary gathering at that Bar under the leadership of Manager and guard of Hype restaurant-Cum-Bar at Planet Mall without mask. On being asked the above noted persons stated that they were well aware of the COVID-19 pandemic situation and disobeyed the Govt guidelines without any valid reason.

Hence all of them violated the order of Govt. of West Bengal duly promulgated and circulated by Civil and Police authorities in order no -**753/XV-ISS/2M-22/2020 dated 30.11.21** that in terms of the provisions under Disaster Management act 2005 read with West Bengal Epidemic disease, Covid-19 regulations 2020 and in continuation of earlier orders restrictions and relaxation measures as already in force vide aforesaid orders stand extended up to 15.12.21 arising out of order No-**753/XII/-ISS/2M-22/2020 dated 29.10.21 that wearing of facial mask has been made mandatory in public places in the current pandemic disaster situation** and to prevent spread of newly detected coronavirus variant "Omicron". The above noted persons have intentionally refused to comply with the order of Govt. of West Bengal duly promulgated in view to stop the break- out of Pandemic COVID- 19 throughout the Country. Accordingly I arrested them after issuing proper arrest memo and maintaining health protocols ensure their safety and security.
