Sir,

In producing here with the one accused person namely Gyan Bahadur Pradhan (61) s/o Late Dambar Bahadur Pradhan, of Salugara, Near Salugara High Salugara, Pipe Line, Ward no 42, PS Bhaktinagar, Dist- Jalpaiguri along with following seized articles as per proper seizure list:


1. Twenty Four (24) bottles of Tuborg Strong Premium beer each bottle containing 650ml.
2. Twelve (12) bottles of Kingfisher Strong Premium beer each bottle containing 650ml.

I, ASI Dipak Karmakar of Bhaktinagar PS under Siliguri Police Commissionerate lodged this written complaint against the above noted accused person to the effect that on 07/12/2021 at 14.15 hrs during mobile van duty at Bhaktinagar PS area received information from source that one person namely Gyan Bahadur Pradhan has huge amount of liquor at his restaurant name and styled as "HIMALAYAN RESTAURANT" situated at Salugara Bazaar under Bhaktinagar PS for selling the same illegally to the local customers. Accordingly the information share before you and as per your kind direction myself along with Constable C/374 Debraj Biswas, CVF- 614 Sumit Kr Roy, CVF, 619 Dharmendra Roy headed towards Salugara to verify the veracity of the information. At about 14.25 hrs we reached at Salugara and entered at the aforesaid restaurant and apprehend the owner who disclosed his identity as noted as above and searched and recovered (i) Twenty Four (24) bottles of Tuborg Strong Premium beer each bottle containing 650ml and (ii) Twelve (12) bottles of Kingfisher Strong Premium beer each bottle containing 650ml. On enquiry the apprehended person admitted his guilt and stated that he has been storing and selling the above recovered liquor to the local customer since long without any valid licence or Documents for his wrongful gain. Accordingly, I prepared seizure list of the above noted articles in presence of witnesses duly sign by the accused as well as witnesses. The seizure made between 14.45 hrs to 15.05 hrs. As he has violated the rules and norms of Bengal Excise Act hence I arrested the apprehended accused person u/s 41 Cr.P.C appraising him the ground of arrest.

I, therefore pray before your kind honour that a specific case may be started against the accused person namely Gyan Bahadur Pradhan (61) s/o Late Dambar Bahadur Pradhan, of Salugara, Near Salugara High Salugara, Pipe Line, Ward no 42, PS Bhaktinagar, Dist- Jalpaiguri under proper section of law and arrange for its investigation.
