Respected madam,

I, Smt Mampi Sarkar, wife of Sri Uttam Sarkar, matrimonial house situated at Shankar more, Jyotiragar Colony, ward no 4, P.O and P.S - Siliguri, District - Darjeeling would like to lodge this complaint to the effect that I was married to Sri Uttam Sarkar resident of Shankar more, Jyotiragar Colony, ward no 4, P.O and P.S - Siliguri, District - Darjeeling on 9th July 2011. Our marriage was consummated and a female child namely Prachi Sarkar was born from our wedlock, who is presently 8 years old.

After lapse of few years of our marriage my husband's ill behaviour and temperament issues enlightened my life. My husband used to pick quarrels without any reason and abused me. On the first instance I did not pay any heed with thought that my husband's behaviour towards me might get changed with passing days but things were just the contrary. My husband has no love and affection towards me and always ill-treated me. Out of temperament issues my husband on several occasions slapped me and abused me with the harshest languages. As our daughter grew up on several occasions my husband used to come home drunker condition and abused me physically before my daughter.

My husband taunts me for not providing my husband a lumpsum amount of dowry and when I raised my voice I am subjected to vulgar slangs and bad gesture from my husband which broke down my self respect a numerous time.

My every movement in my matrimonial house has spent with mental and physical abuse from my

Thereafter they dragged me with them out of my
friend's house forcefully without my consent and
brought me to my mother's house.

I am being tortured mentally and physically here
by my husband and mother, father. I don't want
to stay with them ~~anymore~~ anymore. They have
confined me here and not allowing me to take
any step further for my own safety. My husband
threatened me that he would drag my entire life
in the court and lodge false case against each and
everyone supporting me.

Hence from the above issue, I am begging
before you to take an appropriate action against my
above mentioned husband and mother father for
their misdeeds with me throughout these years
and provide me with justice.
