Sir

It is intimated with due honour that I, Smt. Kanika Kundu Rtd Senior Teacher of K.V. Sukna. I purchased 33 decimal land (out of 98 decimal land) from Shiochand Bhagat in 1989 and took possession and I have been enjoying the land since then after purchasing it. I gifted my land to my daughter's name Smt. Payal Bhattacharjee in 2018. She is PGT Computer Teacher at K.V. Kanchrapara-I in Nadia District.

Smt Sagari Barman (Singha), Sri Ananda Barman, Sri Kartik Barman, Miss Babli Barman, Smt Tili Barman filed a title Suit case no. 251/2018, against me and my daughter with a fake Deed to harass me. I submitted all the required documents, deed & chain deed, proper records and investigation report of the BLLRO office. They failed to produce required documents and deed & record. They failed to prove their possession also. The Court gave verdict in my favour and dismissed the tittle suit case and allowed me to enjoy the land as usual. My labourers were cleaning the weeds and walls on 05/12/21, at that time Mr. Kartik Barman threatened my labourer to stop the work. I submitted an application to intimate at Matigara PS on 5th December 2021. I was very astonished and perplexed to see that the very next day (6th December 2021) Smt Sagari Barman (Singha) and Tili Barman along with other land mafias were digging the land with spade and were taking photographs of their work. I tried to convince them then the result of suit case and told to stop the work. I was harassed, threatened and instigated by them. They said "you do whatever you like". We will take possession by force. Then I called the police they arrived on the spot (Mr. Uttam Choudhury) and stopped the work. I feel insecure and for their words & actions. They might attack me and can try to take possession forcefully. I appeal to you to take leagal action for saving my land and life. I am alone and helpless senior widowed citizen. I request you to give me police protection.
