Vide WiDE Smt Sagari Barman (Singha), Sri Ananda Barman, Sri Kartik Barman, Miss Babli Barman, Nul 334 Smt Tili Barman filed a title Suit case no. 251/2018, against me and my daughter with a fake nr Hiy wuDeed to harass me. I submitted all the required documents, deed & chain deed, proper records and investigation report of the BLLRO office. They failed to produce required documents and deed & record. The Court gave verdict in my favour Mang and dismissed the tittle suit case and allowed me to enjoy the land as usual. I was very astonished and perplexed to see that the very next day (6<sup>th</sup> December 2021) Smt Sagari Barman (Singha) and Tili Barman along with other land mafias were digging the land with spade and were taking photographs of their work. I tried to convince then then the result of suit case and told to stop the work. I was harassed, threatened and instigated by them. They said "you do whatever you like". We will take possession by force. Then I called the police they arrived on the spot (Mr. Uttam Choudhury) and stopped the work. I feel insecure and for their words & actions. They might attack me and can try to take possession forcefully. I appeal to you to take leagal action for saving my land and life. I am alone and helpless senior widowed citizen. I request you to give me police protection.
