Sir,

In producing herewith Five (05) arrested accused persons namely (i) Md. Samaru (27) S/O Lt. Md. Khurshed of Matigara Bazar, P.O+P.S- Matigara, Dist- Darjeeling, (ii) Shiba Chettri (19) S/o Lt. Suresh Chettri of Sourini Bazar, P.S- Mirik, Dist- Darjeeling, (iii) Dinesh Suba (21) S/O Lt. Sujal Subba of Gok Bazar, P.S- Pul Bazar, Dist- Darjeeling, (iv) Arjeman Sk. @ Aru S/O Lt. Abdul Zubbar Sk of Chetni, P.S- Beldanga, Dist- Murshidabad A/P Biswas coloy, P.O+P.S- Matigara, Dist- Darjeeling, (v) Karim Sk. (42) S/O Lt. Abdul Arsid Sk. of Chetni, P.S- Beldanga, Dist- Murshidabad A/P Biswas coloy, P.O+P.S- Matigara, Dist- Darjeeling arrested u/s- 41 Cr.P.C along with following seized articles viz:

- (1) One iron made Crowbar measuring 26 inch (approx) in length from the possession of Md. Samaru which was kept on his right hand,
- (2) One Iron rod measuring 40 inch (approx) in length from the possession of Shiba Chettri which was kept on his right hand,
- (3) One iron made 'Hammer' measuring 10 X 4 X 4 cm (approx) having bamboo handle measuring approx 32 cm in length from the possession of Dinesh Suba which was kept concealed on his back side,
- (4) One Iron rod measuring 40 inch (approx) in length from the possession of Arjeman Sk. @ Aru which was kept on his right hand,
- (5) One Iron rod measuring 30 inch (approx) in length from the possession of Karim Sk. which was kept on his right hand

I, ASI Nitai Mandal of Matigara PS, Siliguri Police Commissionerate do hereby lodge this complaint against the above noted accused persons namely (i) Md. Samaru, (ii) Shiba Chettri, (iii) Dinesh Suba, (iv) Arjeman Sk. @ Aru, (v) Karim Sk. and (vi) Manmohan, (vii) Kalu and others to the effect that today on 08.12.2021 at 00.05 hrs received a sources information that 10/12 youths have assembled near Laska Bridge under Matigara PS with a view to commit dacoity at Nimtala area. The fact was diarized in GDE vide Matigara PS GDE No-345 dated 08.12.2021. Subsequently, after sharing the information with my superiors and as per their direction, I along with ASI Tapan Das, C/986 Rajib Sarkar, C/1035 Santosh Rabidas, CV/387 Sukumar Barman and CV/155 Sukumar Das left for the place to work out the information.

At about 00.45 hrs after reaching Near Laska Bridge PS- Matigara I met my source and as pointed by the source we started approaching towards the spot and cordoning off the suspected persons as shown by the source with a strong reason to believe that they were preparing to commit some cognizable offence. But, seeing the police party approaching towards them they tried to flee away from the spot. But, on hot chase we managed to apprehend above noted five (5) accused persons namely (i) Md. Samaru, (ii) Shiba Chettri, (iii) Dinesh Suba, (iv) Arjeman Sk. @ Aru, and (v) Karim Sk. along with seized articles from their possession as mentioned above. However the other persons managed to flee away from the spot taking the advantage of darkness. On interrogation the accused persons admitted that they had assembled there to commit dacoity at Nimtala area. It is also revealed from them that Manmohan, Kalu and some others have assembled there with them and planned for committing the dacoity.

I thereafter, seized the above noted weapons under proper seizure in presence of witnesses and being acknowledged by the accused persons. The whole seizure was made in between 01.20 hrs. to 01.55 hrs. Thereafter, I arrested the above noted accused persons u/s 41 Cr.P.C under proper memo of arrests duly signed by the accused persons.

I accordingly brought the arrested accused persons along with seized article at Matigara Police Station for further investigation.

Hence, a specific case may kindly be started under proper section of Law against the above noted accused persons namely (i) Md. Samaru (27) S/O Lt. Md. Khurshed of Matigara Bazar, P.O+P.S- Matigara, Dist- Darjeeling, (ii) Shiba Chettri (19) S/o Lt. Suresh Chettri of Sourini Bazar, P.S- Mirik, Dist- Darjeeling, (iii) Dinesh Suba (21) S/O Lt. Sujal Subba of Gok Bazar, P.S- Pul Bazar, Dist- Darjeeling, (iv) Arjeman Sk. @ Aru S/O Lt. Abdul Zubbar Sk of Chetni, P.S- Beldanga, Dist- Murshidabad A/P Biswas coloy, P.O+P.S- Matigara, Dist- Darjeeling, (v) Karim Sk. (42) S/O Lt. Abdul Arsid Sk. of Chetni, P.S- Beldanga, Dist- Murshidabad A/P Biswas coloy, P.O+P.S- Matigara, Dist- Darjeeling and (vi) Manmohan, (vii) Kalu and others and arrange for its investigation.


