Sir,

I. Kamala Devi Prasad, W/o Mr. Lal Chand Prasad, Hindu By religion, Indian by nationality, presently residing at N.S. Road, Jaigaon, District- Alipurduar-736182, would like to draw your kind attention to the following facts:

1. That I am the owner in possession having lawful right, title and interest in land measuring 33 Decimal appertaining to and forming part of R.S. Plot No. 18 corresponding to L.R Plot No. 280 of Mouza =Pelku, in the District of Darjeeling.
2. That thereafter I mutated the land at the office of the B.L. & L.R.O Matigara and L.R. Khatian being No. 1850 was duly issued in my name .
3. That today i.e, on 07.12.2021, I got an information from the local resident that one Shila Das, W/o Sri Santosh Kumar Das, resident of Naukaghat Main Road along in accomplices with some other local land grabbers entered into my land and started cutting the soil with an intention to construct on the land and take possession of the same.
4. That on getting the information I immediately left my home and rushed to the land and tried to restrain the aforesaid miscreants from taking illegal possession of the land but the said miscreant threatened me and my associates with life using filthy and abusive language and claimed that they would take possession of land in any manner possible.

That I am in a dilemma that the miscreates may at anytime take illegal possession of the land and hence a strict necessary legal action must be taken against the above named accused persons as early as possible preventing them from their illegal activities and to give security to my life and property.


