Respected Sir,

I, Farida Begum, W/o- Tipu Ansari, D/o- Mukesh Khan, Muslim by Religion, Housewife by Occupation, presently residing at C/o- Anika Das, Rana Basti, Ward No. 18 of S.M.C, P.O. & P.S.- Siliguri, Dist. Darjeeling, Pin No. 734001, would like to report you the following facts:-

- 1) That 6 (six) years ago my marriage was solemnized with my husband Tipu Ansari, Son of Lt. Ainul Ansari of Vill. Uttar Aathiyabari, P.O.- Barpeta Road, P.S. & Dist.- Barpeta, Assam according to Muslim law, rites, customs at my father's house at Vill. Amingaon, Muria Patty, P.O.- Amingaon, P.S.- Jalukbari, Dist. Dispur, Assam.

At the time of marriage my father gave cash Rs. 2,00,000/- (Two Lack) only by cash husband and different gold ornaments and Furniture and beddings etc. and other household articles to my husband as Dowry as per demand of my husband and his Family members.

After my marriage I started to live with my husband in my in-laws house residing jointly, but few days later my mother-in-law, elder brother-in-law & Sister-in-law namely Rabiya Begum, Jaynul Ansari & Ruhi Khatoon misbehave with me without any reasonable ground. Few days later I saw that my husband was not maintain a good relation with me as a husband and wife and he was continuously told me that he not satisfied of our marriage. I ignored everything which was bad for our relationship.

- 2) That it is mention here that my husband is businessman and now we live at Rana Basti, Ward No. 18 of S.M.C, P.O. & P.S.- Siliguri, Dist. Darjeeling and my other in-

laws are Rabiya Begum, Jaynul Ansari & Ruhi Khatoon now live at Tulsinagar, Near Madrasa, P.S. Matigara, Dist. Darjeeling, but maximum days of week all the members of in-laws are live at my present address. My husband and in-laws demand the money of Rs. 1,50,000/- (one lack and fifty thousand) only from my father's house and in this days my husband and his family members have started mentally and physically to tortured me and they have manhandle me by keeping me in the dark room locking it from outside they even does not give me to eat food and severely beat me every night with drunk condition.

- 3) That out our wedlock between me and my husband has one female child age about 6 years and one male child age about 1 year.
- 4) That also informed you that without my permission my husband sold all my gold ornaments which for his personal reason. That why my husband and my in-laws torture and used various filthy language upon me.
- 5) That every night my husband came at house as huge drunk condition and started to assault me by fists and blows and by kicks and he dragged me out of house by catching my hair log and started to abuse me in filthy and offensive language and told me that until and unless I do not bring cash of Rs. 1,50,000/- (one lack and fifty thousand) from my father's house he will not allow me to live in his house.
- 6) That I came to know that since long my husband has living relationship with Simran Khatoon, D/o- Lt. Jahangir & Sabia of Khureshi Mahalla, Fakir Tala, W. No. 6 of S.M.C, P.S. Siliguri, Darjeeling and even on several occasions Simran Khatoon threatened me if I restrained my husband to meet with her then she will be expose all the Photos and videos of mine which was provided by my husband. Even till now my husband blackmailing me on the same grounds.
- 7) That on 05.12.2021 when I stay at home alone then in the main time Jaynul Ansari (elder brother-in-law) touch at my secret body parts with bad intension and forced to intercourse by lying down me on bed and he told me no one can be know about the incident. Then I told him that I am pregnant so, kindly leave me, but he continuously do same things and somehow I manage to escape from the house and stay at neighbour house until my husband came.

- 8) That next day on 06.12.2021 when I told all the incidents to my husband he does not believed me and my husband drove me out from my room and locked the room but at the intervene of the in-laws namely 1) Jaynul Ansari (elder brother-in-law), 2) Ruhi Khatoon (elder sister-in-law) & 3) Simran Khatoon have come to interfere in our personal conjugal matter and have threatened me that if I don't listen to my husband they will throw me out of my house along with locality.
- 9) That on last night of incident I faced huge bleeding and pain in my lower portion and then early morning my husband providing me some medicines i.e UNANTED KIT (Kit of Mifepristone Tablets & Misoprostol Tablets IP) and suggest me to take the medicine. After taking all the medicines my lower portion body pain was increased and I was senseless.
- 10) That on 08.12.2021 I visit the Doctor at Siliguri Sadar Hospital as per my physical condition the Doctor suggest to me to admit at Hospital as soon as possible.

Presently I am suffering from mental depression and disappear of human activity for this various reasons.

I, therefore request you to kindly take necessary legal action against the aforesaid persons namely 1) Tipu Ansari (husband), 2) Jaynul Ansari (elder brother-in-law), 3) Rabiya Begum (Mother-in-law), 4) Ruhi Khatoon (elder sister-in-law) & 5) Simran Khatoon for their commission of the aforesaid offences.
