my shop namely M/s Bichan Jewellers, Santoshi Nagar
at that time, our neighbour namely, (1) Dina Roy
s/o Not known (2) Smt. Sandhya Roy w/o H. Rajesh
Roy (3) Rajkumar Roy @ Nepali s/o Not known,
all are resident of Santoshi Nagar (Near Santoshi
Mandir), ward no 5 SMC, P.O. Siliguri Bazar, P.S.
Siliguri, Distt- Darjeeling, entered into my Jewellers
shop, M/s Bichan Jewellers, Santoshinagar and started
abusing me in filthy languages and when my

started beating me and my mother with fist and

ourselves at Siliguri Distt-Hospital, where the
