Dear Sir,

With due respect I the undersigned would like to inform you that I am the constituted power of attorney holder of Sri Debaru Roy, S/o. Late Bhagu @ Bhakus Roy @ Bhastu Singh and said Sri Debaru Roy and his mother Smt. Batashi Roy, brother Sri Prasenjit Roy, daughter Smt. Nayaneshwari Roy and his niece Bimala Roy all are the joint owners of a piece of land measuring about 11.68 Acres by virtue of the inheritance of Bhagu @ Bhakus Roy @ Bhastu Singh (since deceased) who acquired the said land by virtue of succession and purchase (photo copy of khatian and sale deed are enclosed herewith).

I would like to further inform you that very recent one Sri Atul Chandra Ghosh, S/o. Late Abhay Chandra Ghosh of Rabindra Nagar, Netaji Colony, P.O. Rabindra Sarani, P.S. Silliguri, Dist. Darjeeling and his men and persons have tried to enter into a portion of the above mentioned land and make a structure thereon with an intention to grab the said land and I along with another being the constituted attorney holders of the above mentioned persons filed a suit before Civil Judge Junior Division, Jalpaiguri being T.S. No. 459/2021 against said Mr. Ghosh.

I would like to further inform you that the Ld. Court was pleased to fix the date on 22.12.2021 for hearing and getting knowledge regarding the institution of the said suit, said Mr. Ghosh and his associates have most illegally started to make construction in and over the said land most illegally and for grabbing the said land and changing the nature and character said land for their ulterior motive and illegal gain.

I would like to further inform you that said Mr. Ghosh and his associates have no faith upon the court of law and police authority as because when I requested his associates to stop the said illegal construction and act, they did not pay any heed to that and moreover they threatened me with dire consequences and told me that no body can resist them for doing such act and thus they are looking opportunity to grab the said land of the poor and rustic villagers.
