I, Satnam Kaur, W/O Late Jasbinder Singh R/O Shibrampally Near, Japan More, Haiderpara, Ward no-39, of S.M.C. P.O-Haiderpara P.S-Bhaktinagar Dist-Jalpaiguri would like to bring this into your kind notice that on 06/12/2021 at around 20:15 PM one Harbinder Singh @ raju Singh s/o Late Swaran Singh resident of Gandhi Nagar, Dist. Jalpaiguri, P.S. Bhakti nagar, having his place of Business under the head 'Daljeet Tyre Works', Lala Lajpat Rai Road, Ashram Para, Dist. Darjeeling, West Bengal broke into my house in a heavily intoxicated condition, during the Presence of my 15 years old grandson and pushed me and tried to disrobe me. When I tried to resist his dirty actions by shouting and pushing him, he lifted a flower pot nearby and hit across my head and subsequently tried to strangle me with an intention to

On hearing my voice my grandson rushed into the place and tried to rescue me to which Harbinder Singh took out a knife and attempted to hit my grandson however no injury was cause to him. With sustained injuries and bleeding head my grandson managed to rescue me and informed my son who reached there immediately without undue delay and took me to hospital.

That such an attack was also attempted by him previously with me and my daughter in-law and a complaint to that effect was lodged at Panitanki T.O.P under Siliguri Police Station.

I request you to take strong and deterrent action against such miscreant and book him under relevant penal law as under the law of the land.

That the delay in lodging this complaint has been caused due to my inability to move out due to injuries as prescribed by my doctor.
