Sir,

I, Suresh Agarwal, Son of Sri Om Prakash Agarwal, residing at
Burdwan Road, Siliguri, do hereby beg to lodge this FIR as follows:-

1. That on 8/12/21 at about 11:30 p.m. while my nephew's car bearing registration no WB74 AS 2323 (MARUTI WAGON R) was crossing Makkhanbhai Sweet Shop at Sewaka road, another vehicle bearing No WB74 AC 9655 (MARUTI Swift) was coming from the opposite side using the wrong lane.
2. The said vehicle bearing no. WB74 AC 9655 was coming from the wrong side in high speed & apparently the driver of such vehicle was totally drunk & was driving in a negligent manner.
3. In such circumstances the said vehicle bearing no. WB74 AC 9655 badly ranned into my nephew's vehicle resulting in severe damage to my nephew's vehicle & has caused grievous hurt to my nephew i.e; (1) Sri Ayush Mittal, s/o Sri Shyam Sunder Mittal, his sister (2) Sweta Mittal w/o Sri Shyam Sunder Mittal & his mother (3) Rekha Mittal w/o Sri Shyam Sunder Mittal. The said 3 individuals are now admitted in Shanti Nursing Home in critically injured condition & undergoing treatment.
4. Such acts on the part of the driver of the vehicle being no. WB74 AC 9655 amounts to serious offences under the Indian Penal Code by intentionally dowing the car in a dangerous & desperate manner which is likely to cause death & grievous injury to others.
