Since after my marriage, my said husband and his relatives namely (1) Jalpai Sahani s/o Lt. Laxman Sahani (2) Smt. Anita Sahani w/o Sri Jalpai Sahani, both are of 2 No. Chunti, P.O & P.S- Jalpaiguri, Distt- Jalpaiguri, and (3) Ranjit Sahani s/o Sri Upendra Sahani, resident of Kholaibakhtai, Thokkar, P.S-Matigara (Near 4th Mahananda Bridge) Distt- ~~Jalpaiguri~~ Dajeling, started subjecting me for physical and mental cruelty.

husband alongwith his relatives namely (1) Ranjit Sahani s/o Sri Upendra Sahani (2) wife of Sri Upendra Sahani, called Pachariwadi (3) Smt. Dipmala Sahani w/o Sri Ranjit Sahani, all both are resident of Kholaibakhtai, Thokkar (Near 4th Mahananda Bridge) P.S-Matigara, Distt- Dajeling, came to my parental house at Maharaj colony, ward No. 5 SMC, P.O P.S-Siliguri, Distt- Dajeling, and started abusing me and my mother namely, Smt. Janki Sahani w/o Sri Kanhaiya Sahani and my father namely Sri Kanhaiya Sahani s/o Lt. Kishori Sahani, and beaten me with fist and blows and threatened me for dire consequences.

So, please take necessary action against my said husband & his parents and his above named relatives.
