Respected Sir,


This is to inform you that I have been in NBMC since over a month for my mother's treatment on 14/11/2021, at around 6:40 am, when I woke up, I found my bag missing from in front of Hair DT complex (M.O.T.). Therefore, I pray, you look into the matter, so that I can recover my bag along with the valuables.


