Yesterday i.e., on 11.12.2021 at about 11:00 PM one Nandan Saha resident of Namita Apartment, DBC road, Siliguri, came to my shop at "Madhuchhanda Biriyani House", NTS more, Deshbandhupara, Siliguri while was checking all transactions at my cash counter and was on preparation of closing the shop along with my staffs Ashim Bhowmick and Tushar Biswas.

Said Nandan Saha was in drunken Condition and was demanding Rs.10000/- from me which I borrowed from him earlier, when I refused to give him back his money stating that I will refund it tomorrow, but he became furious and snatched all money from my hand which I was counting at that time. While I was protesting upon such act he hit me on my forehead, nose, and arm with an iron rod, with an intention to kill me and as such I fell down and started bleeding then he fled away threatening me to kill if I lodge any complaint over the aforesaid incident. Thereafter my staffs took me to the Siliguri District Hospital, where I was given First Aid treatments. It is to mention that at that time I had around Rs.7000-10000/- in my hand which was snatched by said Nandan Saha.

In such a situation I am extremely scared and terrified and feeling helpless. Therefore, I request you to investigate into the matter and to ensure that said Nandan Saha is exemplary punished for his aforesaid offence.
