Sir,

I ASI Gopesh Ch Barman of Panitanki TOP under Siliguri PS/SPC beg to report that on 15/11/21 one Ashim Sengupta S/O Lt S.P Sengupta of Shivrampally, Ward No-39, Haidarpara, PS Bhakti Nagar, Jalpaiguri lodged a written complaint to the effect that on 15/11/21 morning around 06:45 am to 07:00 am his nephew named Rupsha Sengupta D/O Kalyan Sengupta was hit by a truck No WB76/7810 at Swamiji More. As a result the victim received grievous injury and admitted at Neotia Getwel Hospital, under Matigara P.S. Over this complaint IC Siliguri PS recorded this case and endorsed to me for its investigation. Accordingly I took up investigation of this case.

During investigation of this case I took up all informative actions and seized the offending vehicle having Registration No WB76/7810 loaded with sand under proper seizure list. During further investigation of this case it also came to know that during the time of accident the above noted seized vehicle having Registration No WB76/7810 was driving by accused driver Uttam Roy, S/O Lt Annya Roy of Chilkapara, PO- Shikarpur, PS Rajganj, Jalpaiguri. Today as per source information I arrested the above noted accused persons and interrogated him. On interrogation he confessed his guilt. On demand he failed to produce any valid Royalty/Challa in support of said loaded sand. He also stated that he along with the owner of above noted vehicle is jointly stolen the loaded sand from Gajaldoba side with a view to earn money illegally.

Under the above circumstances there is sufficient reason to believe that, the driver Uttam Roy S/O Lt Annya Roy of Chilkapara, PO- Shikarpur, PS Rajganj, Jalpaiguri along with the owner of above noted vehicle have been stolen the loaded sand from Gajaldoba side without any legal royalty/papers as per rule, for selling clandestinely. Accordingly, I seized the said vehicle having Registration No WB76/7810 loaded with sand under proper seizure list duly signed by witnesses in c/w Siliguri PS case No 1325/21 Dated 15.11.21 u/s 279/338 IPC and arrested the above noted offending driver in c/w this case.

Under the above circumstance I pray before you that a separate specific case may kindly be started against the driver named Uttam Roy, S/O Lt Annya Roy of Chilkapara, PO- Shikarpur, PS Rajganj, Jalpaiguri and its owner of above noted seized vehicle Reg No WB76/7810 and arrange for its investigation.
