Sir,

I, Sri Manoj Paul, Assistant Engineer(E) & Station Manager, Hakimpara CCC, WBSEDCL, Siliguri do here by lodge complaint against Manager, Basu's Clinic Health Care Pvt. Ltd., Nandalal Bose Road, College Para, Siliguri, Dist-Darjeeling for having committed offence as stated here under.

On 13.12.2021 at about 01.30 p.m. acting on a source information I, along with 1) Malay Kr. Goswami, D.E. (E), S&LP Wing, Darjeeling Region, WBSEDCL, (2) Biswajit Ghosh, Sr. T.S.H., Hakimpara CCC and other officials of WBSEDCL entered the commercial building of Basu's Clinic Health Care Pvt. Ltd., Nandalal Bose Road, College Para, Siliguri, Dist-Darjeeling and inspected service installation, metering installation of Consumer ID 412056892 in the name of Sri Ashok Kumar Das. During inspection it was found that electricity was being used unauthorisedly & illegally by Manager, Basu's Clinic Health Care Pvt. Ltd. the present user of Consumer Id.-412056892 by breaking the seal (seal no.-XG6606134) and reconnecting the disconnected service line of the metering installation that was disconnected previously on 04.07.2017 due to non-payment of outstanding energy bill amounting to Rs. 1279.00.

As unauthorised reconnection of the disconnected service line and metering installation was detected the energy meter make Bente Electricals & Elec Ltd, serial no.- B3788367 along with seal no.- XG6606134, installed against Con Id. 412056892 seized by preparing a formal seizure list duly signed by representative of Manager, Basu's Clinic Health Care Pvt. Ltd. and witnesses. The copy of the seizure list handed over to representative of Manager, Basu's Clinic Health Care Pvt. Ltd. and his signature obtained as token of receipt.

As Manager, Basu's Clinic Health Care Pvt. Ltd. has committed offence u/s 138(1)(b) of Electricity Act 2003 by using electricity illegally & unauthorisedly by reconnecting the disconnected service line, you are requested to take cognizance of the same by treating this complaint as FIR. The seized articles are packed and labelled by me.
