Dear Sir,

1. On date 14 Dec 2021, at around 1600 hrs, Mr. Sahid and party were constructing road on A-1 def land, near Sukna Military station, which is direct violation of existing law & order.
2. On asking the individual to stop the construction, he along with several civilians started agitation and began to argue and challenged army authorities. Moreover he threatened that the work will continue.
3. Seeing the sensitivity of situation, local police was called and Police Van arrived at site at around 1740 hrs and then the crowd could be handled.
4. In view of above, it is thus requested that, the construction activity must be ~~ear~~ stopped with immediate effect and the person constructing it must be enquired about the legality of this construction, and appropriate legal action may be initiated.
5. An early action will be highly appreciated.
