I am staying with my husband Chitta Ranjan Roy and father -in -law Subodh Chandra Roy , Mother – in – law Mamata Roy , brother- in law Manaranjan Roy.

For few years my husband and the in- laws named above has been harassing me for dowry and was mentally torturing me. I as a lady tolerated all the tortures but now for few months my husband along with the in- laws has started to beat me with fists and blows and even bring sticks and knife asking me to bring dowry or they will kill me.

My husband and in-laws also beat my son and try to take him away from me. When i object they beat me mercilessly.

When my relatives try to make them understand they also threaten my relative with dire consequences.

I am unable to stay peacefully and as such I request you to look after the matter immediately and to ask my husband and in-laws to stop torturing me and harass my relatives otherwise there is every possibility of killing me and my son by my husband and in- laws.

I therefore request you to take necessary action against the persons named above at an earliest for which I shall remain ever grateful
