The aforesaid land is situated at Rabindra Sarani near Rabindra Sarani club. Consequently one khatian has opened in my name vide khatian no. 11345 in

plot no 1265 in Baramohan Singh mouza at B.L.&L.R.O Matigara Block. Since the date of execution of said gift deed I have been the possessing the land

without any interruption or any hinderence. Today I have heard some person is digging the land for the purpose of construction. Instantly I along with my

daughter appeared there and asked the labours under whom instruction they are doing such illegal digging work in and over my land that time they

replied local 1) Sri Suresh Barman, S/o. Unknown, 2) Sri Sujit Roy, S/o. unknown, 3) Sri Subhash Poddar, S/o. Unknown, 4) Bikash Singha, S/o. Unknown. All are resident

of Rabindra Sarani, P.O. Kadamtala, Dt. Darjeeling given contract for digging work for the purpose of construction. Some moment latter the abovesaid

miscreants came there and starting using filthy languages to us when we raised vehement objection they attacked me on my person by fist blows and

and also torn my saree. My daughter some how saved me from the abovesaid miscreants and we leaved the place for save our life.

In this above circumstances I am requesting you to kindly investigate the above-said matter and take appropriate step against the abovesaid land grabbers and thus kind obillige me.
