land. This plot of land exclusively belongs to me and I have inherited the said land and I have legal documents to establish the ownership of the land. I have been illegally disposed from my own land.

Thereafter when I told the miscreants the same and raised objection stating that this plot of land belongs to me and I have valid and legal documents relating to this land the aforesaid persons along with their men and agents used abusive languages towards me and came to hit me with iron rod and bamboo. Thereafter they gave me threat to kill me and threatened me that if I gave any obstruction over their construction work in my land they will end my life. I was also threatened with dire consequences.

That on 28-11-2021 I informed the above mentioned entire incident before the Officer-in-Charge, Matigara Police Station, under Siliguri Police Commissionerate but thereafter I was given a receive copy of the complaint. On 29-11-2021 I was called in Matigara Police Station by ASI Mirja Hossain who was the duty officer and after reaching there I found the presence of the above named persons in the Police Station. Thereafter I was informed by ASI Mirja Hossain that he wanted to check all the relevant papers in connection with my above mentioned land. After handing over all my relevant documents in connection with my aforesaid land, ASI Mirja Hossain stated that he has some specific documents (Baina nama) produced by the above named persons where it reflects that on 7th day of March 2019 I have entered into a Deed of Agreement for Sale with the following persons - 1) Sri Ketan Puri Goswami, 2) Sri Dev Kumar Chhetri, 3) Sri Ganesh Kumar Chhetri, and 4) Sri Kumar

Biswakarma through an unregistered Non Judicial Stamp paper. It also contained some signature which is claimed as my signature by S.K. Nazimuddin. Thereafter he also told that they had later purchased the said land from 1) Sri Ketan Puri Goswami, 2) Sri Dev Kumar Chhetri, 3) Sri Ganesh Kumar Chhetri, and 4) Sri Kumar Biswakarma. Thereafter going through the respective Deed of Agreement I discovered that the signature given in the said deed is not my signature and some unknown signature has been forged in my name for the purpose of cheating and illegally possessing my land. Thereafter when I informed the same to ASI Mirja Hossain he misbehaved with me by saying that no action can be taken and asked me to visit the concerned police station on 30-11-2021 and kept the received copy of the complaint in their custody. On 30-11-2021 when I visited the Matigara Police Station I was handed over with a received copy of my complaint vide G.D.E. No.- 1175 dated 30-11-2021. Thereafter on 02-12-2021 when I showed the said received copy to my Ld. Advocate it was found in the portal of Siliguri Police Commissionerate that there was registered some different case in the same G.D.E. no.- 1175 dated 30-11-2021. Thereafter I informed the same to Matigara Police Station where they assured me that they would rectify my G.D.E. No. of my complaint soon. But till date no action has been taken by Matigara Police in my favour. Hence from the above mentioned incident it is crystal clear that my signature has been forged dishonestly and fraudulently with illegal motive to grab my land as more fully described in Schedule.

That on 06-12-2021 I informed the aforesaid incident before the Commissioner of Police, Under Siliguri Police Commissionerate and on 07-12-2021 the matter was placed before the Deputy Commissioner of Police, Under Siliguri Police Commissionerate as per the direction of the Commissioner of Police. Thereafter on 09-12-2021 the Officer-in-Charge of the Matigara Police Station started to investigate the matter from the beginning.

Hence from the above facts and circumstances I request your good office to start investigating the aforesaid matter and take appropriate action by starting a criminal case against the miscreants namely 1) Nazimuddin, (2) Mahafuj Alam, (3) Aftab Alam, (4) Mehtab Alam, (5) Ketan Puri Goswami, (6) Sri Dev Kumar Chhetri, (7) Sri Ganesh Kumar Chhetri, and (8) Sri Kumar Biswakarma under proper Sections of the Indian Penal Code and to stop the present construction and to demolish the structure already built up.

Please take the needful action regarding this matter.


