I, SI Shyamal Dutta Roy of New Jalpaiguri PS, Siliguri Police Commissionerate, do hereby lodge this written complaint against above noted 03 (Three) arrested accused persons namely (i) Soniur Seikh (28 yrs) S/O late Ansarul Sk of Vill- Sersahi, PO- Manda, PS- Kalichak, Dist.- Malda (ii) Ayesa Begam (38 yrs) D/O Sarju Mahammad of Vill- Gomadighi, PO- Kuchia, PS- Islampur, Dist.- Uttar Dinajpur and (iii) Menoka Khatun (21 yrs) W/O Md Kousher of Biswas Colony, Matigara Rail Gate, PS- Matigara, Dist.- Darjeeling (Not verified) to the effect that today i.e on 16.12.21 at about 14.10 hrs received a specific source information that 03 (three) persons including 02 (two) lady persons were standing at near Kamrangaguri Over Bridge under PS- NJP, Dist.- Jalpaiguri with huge quantity of Brwon Suger for delivering the same to their designed<sup>1</sup> customers. Accordingly, the matter was diarized in General diary vide NJP PS GDE No 1245 dated 16.12.21 and subsequently informed the matter to you and being directed, myself along with LSI Supriya Barman, LC/1328 Sangita Maley, C/1052 Pares Rava, VP/08 Laxman Roy and VP/13 Jamirul Islam all of NJP PS, SPC left for Kamrangaguri Over Bridge under PS- NJP, Dist.- Jalpaiguri by Govt Vehicle along with investigation kit to verify the veraciuty of the information in hand vide NJP PS GDE No 1245 dated 16.12.21 and M.C.C. No. 2529/21 dated 16.12.21. Under this circumstances any search warrant or authorization cannot be obtained without affording opportunity for the consealment of eveicences of facility for the escape of the offender.
