Subject: "FIRST INFORMATION REPORT (F.I.R) Regarding to being assaulted/harassed by mob".

Sir,

I, Md. Yousuf, aged about 50 years, son of Late Md. Jharu, resident of Rangapani, Phansidewa, Darjeeling District, West Bengal would beg to crave few lines for favour of your necessary action. Sir, I along with my Sister, Smt. Sebo Begum, wife of Md. Mumtaz, resident of Rangapani, Phansidewa, Darjeeling District, West Bengal have been called yesterday, i.e 15/12/2021 to the house of one patient by name Smt. Rupo Roy, wife of Shri Robin Roy at Raj Pouri, Patharghata, Darjeeling District as we deal with Ayurvedic treatments. On reaching there we examined the patient and gave her medicine. Sir, while we were treating the patient at her home, her husband threw some water on the adjoining land. Sir, seeing which a group of people gathered and attacked Shri Robin Roy and us on our body and on our person. They beat us black and blue and even attempted to kill us. But fortunately, Police Officials reached the spot and rescued us from the terrifying mob and dropped us at NBMCH, Kawakhali, Darjeeling District, wherein I got admitted and treated at NBMCH and my sister out of fear and shame did not get admitted but treated herself at home.

(Copy of the Medical Report of Md. Yousuf from NBMCH dated 15/12/2021 is enclosed herewith).

Sir, the attack was extremely terrible and horrifying and not only this they even looted our money amounting to Rs. 8000/ only and a gold chain and golden earrings. They even threatened us and made sarcastic comments saying that we are Muslim and how can we enter the village of the Hindu Community and shouted that they would kill us and for which they already brought Trishul from somewhere. Sir, we are extremely horrified and saddened by this type of abuse with us. Sir two persons by name Shri Rajiv Shah and Shri Bapi Barman even attacked on the private parts of my sister mentioned above and molested and sexually assaulted her.

Therefore, I request you to please take appropriate action by registering an FIR against (I) Shri Rajiv Shah, (II) Shri Bapi Barman, (III) Shri Pabitra Barman, (IV) Shri Kalicharan, (V), Shri Shyamal Singha, (VI) Shri Goutam Singha, (VII) Shri Uttam Singha, (VIII) Shri Surja Kanta Barman, (IX) Smt. Une Singha, (XII) Smt. Baiji Singha, (XIII) Smt. Niyati Singha, (XIV) Smt. Maya Barman, (XV) Shri Ashinath, (XVI) Husband of Smt. Patili (Jamai Basty) and others nearly amounting to more than 70 people of the same area, so that the accused can get appropriate and strict punishment.
