Sir,

I Sub-Inspector Srimanta Chatterjee of Bhaktinagar Police Station, Siliguri Police Commissionerate after producing one accused person namely MD Yusuf Ali Khan-23yrs s/o Lt Md Maksud Khan of Pokajote, Champasari near Church, Ward No-46 of SMC, PS Pradhannagar Dist Darjeeling and seized total (1) 30 (thirty) strips of Pyeevon Spas Plus capsules each strips containing 24 capsules total-30X24=720 pieces (composition with Dicyclomine Hydrochloride 1P, Tradadol Hydrochloride 1P, Acetaminophen 1P) and (2) 60 (Sixty) bottles of PHENSEDYL Chlorpheniramine Maleate & Codeine phosphate cough Linctus syrup each bottle containing 100 ML contained in a one big size paper cartoon, do hereby lodged written complaint to the effect that on 14.12.21 at 18.05 hrs received reliable source information of SOG, SPC that one person was standing in front of Prakashnagar near Gandhi Math under Bhaktinagar PS with one paper cartoon contained illegal drugs (Capsules & Cough syrup) to deliver the same to someone. It is reasonably believe that the person possessing the cartoon containing capsules & Cough syrup may escape from the scene if Police party did not reach the spot immediately. The information was reduced in writing vide Bhaktinagar Police Station GDE no. 752 dated 14.12.21 and informed superiors about the plan of action. Thereafter myself along with SI Rashbehari Saha, ASI Binod Jha of SOG SPC and ASI Dipak Karmakar, C/374 Debraj Biswas, CVF/935 Biplob Roy and CVF/619 Dharmendra Roy taking blank paper, wax, metal seal and knife and other kits left for Prakashnagar near Gandhi Math to work out the information vide Bhaktinagar PS GDE no-753 dated 14.12.21 & MCC No- 2093/21 dated 14.12.21.

At 18.35 hours I along with officer and force reached near Gandhi Math and contacted the source who show us the person with the big paper cartoon suspected to be contained capsules from a certain distance, I briefed all Officers and force to cordon the person as tactful as possible in order to thwart their escape from the scene. Meanwhile I called two independent witnesses namely 1) Suraj Chhetri @ Raj s/o Man Bahadur Chhetri of Ramchandranagar ward No-42 PS Bhaktinagar Dist Jalpaiguri and (2) Suraj Sah s/o Raj Kumar Sah of Sastrinagar, Near Pateswari School PS Bhaktinagar Dist Jalpaiguri and after apprising them about the information received requested them in written to remain present with us during search and seizure. We rounded him up and questioned about his name and address when he disclosed his identity as above. On interrogation about the cartoon possessing by him, initially did not disclose anything about contains of cartoon. I forced him to open it, when he disclosed that the bag contains capsules & Cough syrup belongs to him. On further interrogation he disclosed that he procured the illegal capsules from one Monoj Bhagat @ Mohit and Murtaza @ Guddu of Champasari side to deliver the same to another person. Then I detained him and gave an option in writing whether he is willing to be searched in presence of an Executive Magistrate or Gazette Police Officer, on return he given written reply that he is willing to be searched in presence of Gazette Police Officer. Then I informed Shri Amaresh Singh, Inspector In-Charge, Bhaktinagar Police Station to come to

Rakshinagar near Gandhi Math requested him to presence during search and seizure of the capsules & syrup.

At 19.10 hrs Shri Amaresh Singh, Inspector In-Charge, Bhaktinagar Police Station arrived at spot. Thereafter I opened the bag and found illegal capsules & Cough syrup inside. I asked the accused person above named to produce document if any in support of possessing such a huge quantity of capsules & cough syrup with them but he failed to produce document. I seized the following articles under proper seizure list in presence of witness under direct supervision of IC Bhaktinagar PS under proper labeling. I informed Drug Controller Jalpaiguri over telephone requesting him to remain present at the spot but he failed to appear the PO.

NATURE OF ARTICLES SEIZED

- 1) Three Paper box containing with 30 (thirty) strips of Pyeevon Spas Plus capsules each strips containing 24 capsules total-30X24=720 pieces (composition with Dicyclimine Hydrochloride 1P, Tradadol Hydrochloride 1P, Acetaminophen 1P) marked as Exhibit-A out of Two strips taken as sample marked as Exhibit-AI (Kept in big paper cartoon)
- 2) 60 (Sixty) bottles of PHENSEDYL Chlorpheniramine Maleate & Codeine phosphate cough Linctus syrup each bottle containing 100 ML marked as Exhibit-B out of two bottles taken as sample marked as Exhibit-BI (Seizure was made in between on 14.12.21 in between 19.50 hrs to 21.10 hrs)

Under the above circumstances it is evident that the accused person above named procured has committing offence under NDPS act. On interrogation accused person confessed his guilt and stated that he is doing such kind of business illegally with any valid documents/License since long for their wrongful gain. One Monoj Bhagat @ Mohit and Murtaza @ Guddu of Champasari are also involved in this crime. It is crystal clear that the accused persons are peddling prescription drugs meant for the sick people to cater to the need of drugs abusers in the locality illegally which has become menace to the life of the young generation and perishing the home of thousand parents. All the seized contents Psychotropic substance and falls under NDPS act. I arrested them u/s 41 Cr.P.C. after explaining them about the ground of arrest issuing proper memo of arrest. Arrested accused persons along with seized articles brought to PS, seizure list and seized articles handed over to Malkhana dealing Officer under intimation to I.C. PS for keeping record in PS property register.

I therefore pray that a specific case u/s Narcotic Drugs and Psychotropic Substances Act 1985 may kindly be started against the accused persons namely (1) Md Yusuf Ali Khan-23yrs s/o Lt Md Maksud Khan of Pokaljote, Champasari near Church, Ward No-46 of SMC, PS Pradhannagar Dist Darjeeling (2) Monoj Bhagat @ Mohit and (3) Murtaza @ Guddu of Champasari and arrange for its investigation.
