Sir,

I, Suman Sengupta, Son of Ashoke Sengupta, D.E & SM Power House CCC, empowered by The Electricity Act 2003 amended on 2007 of India do here by lodge this complaint against Sri. Ajay Kumar Agarwal, S/O Pawan Kumar Agarwal, Partner, Sivaram Developers having registered office at Sikkim Commerce House, 5<sup>th</sup> Floor, 4/1 Middleton Street, P.O Middleton, P.S/ Park Street, Kolkata-700071, West Bengal, India. While on a routine inspection on the site having consumer id 401364667, meter no SF068523, having power connection by WBSEDCL in the name of Sivaram Developers, the address being The universe, Block Neptune, beside Himalaya Kanya Abasan, Bangla bazar area, P.S Bhaktinagar, Dist- Jalpaiguri, I, Suman Sengupta, Divisional Engineer & Station Manager, Power House CCC along with Sri Sanjay Prasad, Senior Office Executive, Power House CCC, WBSEDCL and other technical staffs found that an unauthorized energy meter ( Servo Tech Jalpur make, Single Phase energy meter, 1/1 no 21Q16, last reading- 7836) (not a property of WBSEDCL) was being used directly via fooking from the WBSEDCL common bus bar and bypassing the common meter SF068523. The unauthorized meter was being used to power a domestic premise, flat no 4 D of the same building where a total load of 10200watts or 10.2 Kilo Watt was observed (1nos of washing machine - 1000 watts, 1 nos of 1.5 tonne A.C- 1500 watts, 1nos of 1 tonne A.C- 1000watts, 1 nos of Fridge-800 watts, 1nos of peyzer-2000watts, 1nos of Microwave- 1200watts, 5nos of fans- (5X100)=500watts, 1nos of T.V- 500 watts, 11 nos of Tubelights- (11X60)=660watts, 1 nos of mixer grinder-800watts, 16nos of LED lights (16X15)= 240watts).

We entered the premises at 1250hrs on 15.12.2021 after handing over Notice to Sri Vikash Agarwal, cousin of Sri Ajay Kumar Agarwal. Then it was observed that the power was being used in an unauthorized manner via direct hooking from the common bus bar and bypassing the common energy meter of WBSEDCL. Thereby committing a crime as per The Electricity Act 2003 amended on 2007 of India under section 135 (1) (b). Accordingly the connection was disconnected and both the energy meters and service cable were seized and labelled. A copy of both inspection report and Seizure list (1. Secure Meter, 3Phase, (3X240 Volts), (5-30) amps, SI No SF068523, property of WBSEDCL, 2. Servo Tech Jalpur make, single phase energy meter with reading of 7836 & 3. Service Cable of Red & Blue Color, Multi-Stranded, Copper wire of 3 meters approx each) were handed over to Sri Vikash Agarwal. We exited the premises on 1352hrs.

Thus you are requested to kindly initiate an investigation against Sri. Ajay Kumar Agarwal under Section 135 (1) (b) of the Indian Electricity act 2003 amended on 2007.
