Respected Sir,

I, Arun Kumar Goyal, aged about 58 years, s/o Late Mahabir Prasad Goyal of Green Valley Apartment, Sevoke Road, Siliguri, West Bengal- 734008 would like to state as follows:

1. That I am a law abiding citizen and also the President of Siliguri Green Valley Welfare Society (Registration No. S/2L/13932/2013-2014) presently situated at Green Valley Apartment, Sevoke Road, Siliguri, West Bengal- 734008.
2. That today at around 8:15 am, while I was sitting in the Garden area of Green Valley Apartment, Sevoke Road, Siliguri along with other residents of the Apartment after the morning walk, suddenly one Shiv Shankar Shastri, resident of Green Valley Apartment, came out of his residence in anger and started dominating and abusing Gardeners of our Apartment in most filthy language by uttering slangs and misbehaving with them for the purpose of preventing them from doing their work. Shiv Shankar Shastri stopped the gardeners from gardening. As a President of Green Valley Welfare Society, looking at such intolerant behaviour of Shiv Shankar Shastri with the Gardening staff of the Green Valley Apartment and in order to save their dignity, safety and security, when I along with other residents of the Apartment tried to balance the situation by interfering peacefully into the matter and enquiring Shiv Shankar Shastri most

3. humbly about the reason for his intolerant behaviour, he became furious and threatened then and there that he will teach me a lesson today by physically assaulting me in front of the whole society and putting my reputation in soil. Thereafter, he called his son, Andy Shastri who came behind my back and manhandled me by giving fists and blows and by giving kicks repeatedly despite my resistance. While hitting me, he tried to spread communal hatred and discrimination between me and other residents of the apartment by uttering slangs on my community and by telling me that I am an outsider in West Bengal. The miscreants did not stop here. Shiv Shankar Shastri attempted to kill me by tying his muffler around my neck and pulling the two ends of the muffler with all his force. I was helpless but somehow I was able to rescue myself with the help of the civilised members of the Apartment.
4. That he has threatened me with dire consequences in most filthy language that in near future he will again attack me and physically assault me as he is an influential person and having no fear of law in his heart and his eyes.
5. That thereafter I was taken to the doctor for the treatment of my wounds by my family and friends.
6. That a photocopy of the prescription issued by the doctor has been annexed herewith.

I hereby request you to look into this matter as expeditiously as possible and take necessary actions against the above-named Shiv Shankar Shastri and Andy Shastri in accordance with laws of the land.
