Sir,

With due respect and humble submission I, Afsha Naz, wife of Md Mehtab, Resident of Ashraf Nagar, near Anchal Bazar, Ward No. 40 of S. M. C., P. O.-Haiderpara, P. S.- Bhaktinagar, District- Jalpaiguri, would like to inform you that today at around 12.30 P.M. when I was alone in the house, two unknown men came to my house and said they have come to clean the Brass handle of the doors. Despite my denial, they voluntarily started cleaning the door handle. When I tried to stop them, they intentionally poured some chemical on my gold bangles which faded the colour of bangles. Having noticed that I reprimanded the persons. However they offered to help me in restoring the colour of my bangles and asked me to fetch water in a pressure cooker. Little moment later one of them again asked to get more water and when I went to kitchen to fetch water they took the gold bangles out from the pressure cooker and left instructing me to put the pressure cooker on gas oven. Somewhat after 10 minutes when I opened the cooker I was astonished to find that bangles were missing.

So, I therefore request you to investigate this matter with utmost priority and trace the culprits and recover the pair gold bangles weighing 46 grams and do the needful at the earliest.
