Sir,

With due respect - I Smt. Punam Gupta W/o Sri Mantu Lal Gupta resident of S. P. Mukherjee Road, Khalpara, P.O & P.S - Siliguri, District - Darjeeling, would like to inform you that on 14 - 12 - 2021 at about 11.15 P.M when my said son Sri Sourav Gupta aged about 23 years S/o Mantu Lal Gupta alongwith his friend Sri Gurdeep Singh were returning from Salugara to Sevoke Road Side by a Motor Cycle (Bajaj Pulsser) bearing registration No - WB - 74 - Z/0877 and when they reached near the traffic point of Eastern By-pass, Check Post, Siliguri, P.O & P.S - Bhaktinagar, District - Jalpaiguri at that time all of a sudden One four wheeler vehicle bearing registration No - WB - 74 - AD/5565 (Mahindra XUV 500) which was coming from Eastern By-Pass and turning towards Salugara side and just on the traffic point of Eastern By-Pass the said four wheeler vehicle hit the motorcycle which was driving by Sri Gurdeep Singh and my son was sitting on his behind and a fatal accident took place and due to said fatal accident, my son Sourav Gupta and the driver of motor cycle Sri Gurdeep Singh sustained serious injuries in their part. After the said accident my son Sourav Gupta was brought to Anandlok Nursing Home where the doctors have declared him as dead and presently Sri Gurdeep Singh is in hospital (Paramount Hospital) and fitting for his life and death.

The said accident took place due to rash and negligent driving of the driver of the said Four Wheeler vehicle bearing registration No - WB - 74 - AD/5565 and due to said fatal accident, my son lost his life.


So requesting you to investigate the matter and take necessary legal action against the driver of the vehicle and oblige me.
