With due respect, I am producing herewith one arrested accused person namely Raja Sahani (19 yrs) S/O- Kamalesh Sahani of Patiramjote near Chourangi more, PS- Matigara, Dist - Darjeeling along with following seized article under proper seizure list:

1. One professional power Amplifier PA HD0 40 +

I ASI Bikash Roy of Siliguri P.S under Siliguri Police Commissionerate do here by lodged the complaint to the effect that, during my night R/T Mobile van duty on the night of 15/16-12.2021, I received an information from inhabitants of New Milanpally near Children Park area under Siliguri PS that some people were playing music system loudly in the house of one Sri Sourav Saha S/O- Lt. Prosanta Saha of New Milanpally near Children Park, Ward No- 25, PS- Siliguri, Dist- Darjeeling at the time of late night. Accordingly, I informed the information to I/C Siliguri PS and as per his kind order, myself along with my accompanied C/217 Md. Enamul Haque and C/384 Biswanath Barman all are Siliguri PS, SPC had been to New Milanpally near Children Park, Ward No- 25 to verify the information. At about 23.25 hrs we are reached there and found that a music system is playing there with high volume and without using sound limiter at late night violating the order of Hon'ble High Court, Calcutta dated 01.04.1996 & 24.02.1997 respectively and the notification no- 753/XV -ISS/2M-22/2020 dated 15.12.2021 of Govt. of West Bengal. However, we were able to apprehended one person who disclosed his name and identity Raja Sahani (19 yrs) S/O- Kamalesh Sahani of Patiramjote near Chourangi more, PS- Matigara, Dist - Darjeeling.

On being asked he admitted their guilt and stated that, he playing sound system in the house of Sri Sourav Saha S/O- Lt. Prosanta Saha of New Milanpally near Children Park, Ward No- 25, PS- Siliguri, Dist- Darjeeling without any permission or licence of civil administration or Police as per instruction of the owner of the said sound system Sri Prasanta Saha S/O- Prantosh Saha of New Milanpally near Children Park, Ward No- 25, PS- Siliguri, Dist- Darjeeling and house owner Sri Sourav Saha. He further stated that they are well aware regarding the order of Hon'ble High Court, Calcutta in c/w use of microphone/sound system at the late night. However, I seized the above noted article under proper seizure list duly signed by the witnesses and arrested the above noted accused persons u/s 41 Cr.P.C. The seizure was made in between 23.45 hrs to 23.55 hrs dated 15.12.2021.

Hence, I pray before your honour that, a specific case may kindly be started against the above noted arrested accused person namely i) Raja Sahani (19 yrs) S/O- Kamalesh Sahani of Patiramjote near Chourangi more, PS- Matigara, Dist - Darjeeling, ii) Owner of the said sound system Sri Prasanta Saha S/O- Prantosh Saha and iii) house owner Sri Sourav Saha S/O- Lt. Prosanta Saha both of New Milanpally near Children Park, Ward No- 25, PS- Siliguri, Dist- Darjeeling u/s- 188 IPC r/w Sec 32 Police Act, 1961 and arrange for its investigation.
