I Hardeep Singh, s/o Tejender Singh, resident of 79/2, Labour colony, Ferozabad, P.S. - Kinepar, Dist. Ferozabad, U.P., at present residing at c/o Subject Roadways, Navjehan apartment Ranjabi Para, P.O. & P.S. - Siliguri, Dist. - Darjeeling begs to report you the following:

- ① That on 12/12/21 at around 01:30 AM a vehicle being no. UP 83T 6258 carrying my goods i.e. (glass) arrived from Ferozabad to Siliguri as it was late night, I told the driver Tinku Rajput who was driving the said vehicle in the army parking area.
- ② That after the driver Tinku Rajput, s/o Ramveer Singh resident of Ferozabad parked the said vehicle in the Army parking area few unknown people name unknown to me came to the driver and started abusing him (driver)

in filthy language and started assaulting him (driver) with fist and blows and kicks and also broke the glass of the vehicle. They also took Rs. 5000/- from the pocket of the driver after beating him hard, and also threatened him with dire consequences. They were around 7 to 8 people and all were under the influence of Alcohol and have hit the driver really hard.
