With due respect and humble submission, in producing herewith one accused namely Nandalal Paswan(40) S/o Lt. Boku paswan of BRI Colony ,P.S-Pradhannagar, Dist. Darjeeling under arrest along with following articles under proper seizure ;

I PSI Sumit Sarkar of Pradhannagar PS, SPC would like to lodge this written complainant against the above noted accused person to the effect that today on 11.12.2021 incourse Special drive duty at PS area with force vide PDN PS GDE NO 644 dtd.11.12.21 , I received an information that one person is storing and selling liquor illegally at back side of NBSTC bus stand under Pradhannagar PS .Accordingly, I share the information to you and as per your kind instruction myself along with , CV/645 Pankaj Gupta , CV/223 Swapan Chhetri rush to the spot and as pointed by the source we apprehended the above noted person with bag and on search his bag recovered above noted articles , On demand he failed to produce any valid document in respect of recovered articles .On interrogation he admitted that he is selling the same illegally without obtaining valid document for his illegal gain. Accordingly, I seized & label the above noted articles in between 20:50 hrs to 21:35hrs and I arrested him.

Therefore, I request you to start a specific case under proper section of law against the arrested person namely Nandalal Paswan(40) S/o Lt. Boku paswan of BRI Colony ,P.S-Pradhannagar, Dist. Darjeeling and arrange for its investigation.
